I. CALL TO ORDER/ROLL CALL

Chair Sirmans called the meeting to order at 4:00 p.m. and Commissioners answered roll call for attendance.

V. EXECUTIVE SECRETARY'S REPORT

April Birthdays – Kedrione Harris

On March 30, 2023, our agency signed a MOU with the Technical College System of Georgia to establish policies and procedures through which the GaPSC will issue certification to educators teaching students enrolled in the TCSG Dual Achievement Program established by SB204 in 2022. For those unfamiliar with this program, the Dual Achievement Program offers qualified students a recognized and alternate path to high school graduation by allowing them to simultaneously earn a high school diploma while completing requirements for either a technical certificate, technical diploma or associate's degree in a career pathway. While SB204 allowed TCSG to waive all

requirements, including certification, they chose to hold their educators to the same requirements as public schools and public charters. We commend their diligence in ensuring competence through certification, and high standards of conduct for their educators. We look forward to our partnership and supporting this program.

The Reading Task Force completed their work on March 21st and I want to say how grateful we are to all the members who participated in that work. You are seeing today the results of their work through the proposed rules, which I believe will transform the way teachers are prepared to teach reading and make a positive impact on our students.

VI. CHAIR REPORT

Chair Sirmans did not have a report this month.

VII. RULES INITIATION

Anne Marie Fenton presented the rules for initiation. Rules were brought before the Commission at the March 9th Commission meeting, which are currently posted for public comment. In addition, in March, we previewed Certification and Educator Preparation rules to come before the Commission today for initiation consideration. As shared earlier, we modified our regular rules cycle to bring to you for your initiation consideration these rules previewed last month so if initiated and ultimately adopted, they can become effective July 1, 2023.

Therefore, we are asking you to initiate 3 Certification and 13 Educator Preparation rules. If initiated, these proposed rules will be posted for a 30 day public comment and come back before you in June for your adoption consideration, to become effective July 1, 2023.

You received the Initiate Rules packet last week. We will request you initiate the rules as presented in your Initiate Rules packet, yet with the following adjustments:

- In Rule 505-3-.03 - FOUNDATIONS OF READING, LITERACY, AND LANGUAGE, on page 17, the P-12 fields of “Computer Science” and “Engineering and Technology” were added to complete the list of P-12 programs. The other P-12 fields were already listed (Art, Dance, Drama, English to Speakers of Other Languages, Foreign Language, Health and Physical Education, and Music).
- In Rule 505-3-.19 MIDDLE GRADES PROGRAM - The opening discussion section on page 1, which is eventually removed when the rule becomes effective, lists the current content area standard references. Added to that section is the reference to the current content area of *English Language Arts (reflective adaptation of the standards published in 2021 by the National Council of Teachers of English [NCTE])*. Already included were the references to Mathematics (reflecting adaptation of the standards published in 2020 by the National Council of Teachers of Mathematics [NCTM]); Reading and Writing (reflecting adaptation of the standards published in 2017 by the International Literacy Association [ILA]); Science (reflecting adaptation of the standards published in 2020 by the National Science Teaching Association/Association for Science Teacher Education [2020] and National Academies of Sciences, Engineering, and Medicine’s Framework for K-12 Science Education [2012]); and Social Studies (reflecting adaptation of the standards published in 2018 by the National Council for Social Studies [NCSS]); and for middle level standards published by the Association of Middle Level Education (2022). In addition, the new rule requires incorporation of the applicable standards specified in GaPSC Rule 505-3-.03, FOUNDATIONS

OF READING, LITERACY, AND LANGUAGE. Also included are revisions to simplify and/or remove ambiguous terms and formatting changes for improved readability.

- Also in the MIDDLE GRADES PROGRAM RULE (505-3-.19), a reference to the date of the standards published by the National Council of Teachers of English was updated to 2021. (Instead of the prior 2017 standards reference).

The rules are as follows:

Certification

505-2-.141 CURRICULUM AND INSTRUCTION - It is proposed that GaPSC Rule 505-2-.141 CURRICULUM AND INSTRUCTION, dated January 1, 2020, be REPEALED and a new rule with the same number and title be INITIATED to clarify that this certificate field is for strengthened and enhanced competency and is not in-field for any teaching, service, or leadership position.

505-2-.142 INSTRUCTIONAL TECHNOLOGY - It is proposed that GaPSC Rule 505-2-.142 INSTRUCTIONAL TECHNOLOGY, dated July 1, 2021, be REPEALED and a new rule with the same number and title be INITIATED to clarify that this certificate field is for strengthened and enhanced competency and is not in-field for any teaching, service, or leadership position.

505-2-.149 TEACHER LEADERSHIP - It is proposed that GaPSC Rule 505-2-.149 TEACHER LEADERSHIP, dated January 1, 2020, be REPEALED and a new rule with the same number and title be INITIATED to clarify that this certificate field is for strengthened and enhanced competency and is not in-field for any teaching, service, or leadership position.

Educator Preparation

505-3-.03 FOUNDATIONS OF READING, LITERACY, AND LANGUAGE - It is proposed that a new rule with a new name, GaPSC Rule 505-3-.03 FOUNDATIONS OF READING, LITERACY, AND LANGUAGE, be INITIATED. This rule will supplement GaPSC Rule [505-3-.01 REQUIREMENTS AND STANDARDS FOR APPROVING EDUCATOR PREPARATION PROVIDERS AND EDUCATOR PREPARATION PROGRAMS](#), and will apply to all GaPSC-approved teacher preparation programs. The rule specifies standards for preparing teachers to teach reading. GaPSC-approved educator preparation providers (EPPs) will be required to implement these standards by Fall 2024.

505-3-.13 BIRTH THROUGH KINDERGARTEN PROGRAM - It is proposed that GaPSC Rule 505-3-.13 BIRTH THROUGH KINDERGARTEN PROGRAM, dated July 1, 2020, be REPEALED and that a new rule with the same number and the same title be INITIATED. The new rule reflects the simplification and/or removal of ambiguous terms, includes updated program content standards, and incorporates the applicable standards specified in GaPSC Rule 505-3-.03 FOUNDATIONS OF READING, LITERACY, AND LANGUAGE.

505-3-.14 ELEMENTARY EDUCATION (P-5) PROGRAM - It is proposed that GaPSC Rule 505-3-.14 ELEMENTARY EDUCATION (P-5) PROGRAM, dated July 1, 2020, be AMENDED to simplify and/or remove ambiguous terms, and to incorporate the applicable standards specified in GaPSC Rule 505-3-.03 FOUNDATIONS OF READING, LITERACY, AND LANGUAGE.

505-3-.19 MIDDLE GRADES EDUCATION PROGRAM - It is proposed that GaPSC Rule 505-3-.19 MIDDLE GRADES EDUCATION PROGRAM, dated January 1, 2020, be REPEALED and that a new rule with the same number and the same title be INITIATED. The new rule reflects current standards for the content areas of Mathematics (reflecting adaptation of the standards published in 2020 by the National Council of Teachers of Mathematics [NCTM]); Reading and Writing (reflecting adaptation of the standards published in 2017 by the International Literacy Association [ILA]); Science (reflecting adaptation of the standards published in 2020 by the National Science Teaching Association/Association for Science Teacher Education [2020] and National Academies

of Sciences, Engineering, and Medicine's Framework for K-12 Science Education [2012]); and Social Studies (reflecting adaptation of the standards published in 2018 by the National Council for Social Studies [NCSS]); and for middle level standards published by the Association of Middle Level Education (2022). In addition, the new rule requires incorporation of the applicable standards specified in GaPSC Rule 505-3-.03, FOUNDATIONS OF READING, LITERACY, AND LANGUAGE. Also included are revisions to simplify and/or remove ambiguous terms and formatting changes for improved readability.

505-3-.48 WORLD LANGUAGES EDUCATION PROGRAM - It is proposed that GaPSC Rule 505-3-.48 FOREIGN LANGUAGE EDUCATION PROGRAM dated October 15, 2015, be REPEALED and that a new rule with the same number and a different title of WORLD LANGUAGES EDUCATION PROGRAM be INITIATED. The new rule reflects updated and modified standards by the American Council on the Teaching of Foreign Languages (ACTFL) (2013, 2015), and incorporates the applicable requirements for the teaching of reading specified in GaPSC Rule 505-3-.03 FOUNDATIONS OF READING, LITERACY, AND LANGUAGE.

505-3-.51 READING EDUCATION PROGRAM - It is proposed that GaPSC Rule 505-3-.51 READING EDUCATION PROGRAM, dated January 1, 2020, be AMENDED to simplify and/or remove ambiguous terms, and to align the program with the science of reading and Rule 505-3-.03 FOUNDATIONS OF READING, LITERACY, AND LANGUAGE.

505-3-.59 SPECIAL EDUCATION PRESCHOOL (AGES 3-5) PROGRAM - It is proposed that GaPSC Educator Preparation Rule 505-3-.59 SPECIAL EDUCATION PRESCHOOL (AGES 3-5) PROGRAM, dated May 15, 2014, be REPEALED and that a new rule with the same number and the same title be INITIATED. The new rule reflects the simplification and/or removal of ambiguous terms, includes updated program content standards, and incorporates the applicable standards specified in GaPSC Rule 505-3-.03 FOUNDATIONS OF READING, LITERACY, AND LANGUAGE.

505-3-.66 LITERACY SPECIALIST PROGRAM - It is proposed that GaPSC Rule 505-3-.66 LITERACY SPECIALIST PROGRAM, dated July 1, 2020, be AMENDED to remove ambiguous terms, and to align the program with the science of reading and GaPSC Rule 505-3-.03 FOUNDATIONS OF READING, LITERACY, AND LANGUAGE.

505-3-.76 ALTERNATIVE PREPARATION FOR EDUCATIONAL LEADERSHIP PROGRAM - It is proposed that GaPSC Rule 505-3-.76 ALTERNATIVE PREPARATION FOR EDUCATIONAL LEADERSHIP PROGRAM, dated January 1, 2021, be AMENDED to remove references to national teacher preparation standards and replace them with state-developed standards for teacher performance; to remove outdated language and statements related to a limited number of eligible program providers; to simplify and/or remove ambiguous terms; and to require programs to ensure educational leaders are aware of the principles of the science of reading and their impact on effective reading instruction, as specified in GaPSC Rule 505-3-.03 FOUNDATIONS OF READING, LITERACY, AND LANGUAGE. Formatting changes are also included to improve readability.

505-3-.77 EDUCATIONAL LEADERSHIP PROGRAM - It is proposed that GaPSC Rule 505-3-.77 EDUCATIONAL LEADERSHIP PROGRAM, dated January 1, 2021, be AMENDED to remove references to national teacher preparation standards and replace them with state-developed standards for teacher performance; to simplify and/or remove ambiguous terms; and to require programs to ensure educational leaders are aware of the principles of the science of reading and their impact on effective reading instruction, as specified in GaPSC Rule 505-3-.03 FOUNDATIONS OF READING, LITERACY, AND LANGUAGE. Formatting changes are also included to improve readability.

505-3-.82 BIRTH THROUGH KINDERGARTEN ENDORSEMENT -It is proposed that GaPSC Rule 505-3-.82 BIRTH THROUGH KINDERGARTEN ENDORSEMENT PROGRAM, dated July 1, 2021, be REPEALED and

that a new rule with the same number and a different title, BIRTH THROUGH KINDERGARTEN ENDORSEMENT, be INITIATED. The new rule includes updated program content standards and reflects the simplification and/or removal of ambiguous terms.

505-3-.96 READING ENDORSEMENT - It is proposed that GaPSC Rule 505-3-.96 READING ENDORSEMENT PROGRAM, dated July 1, 2021, be AMENDED to remove the word *program* from the title, simplify and/or remove ambiguous terms, remove the opportunity to embed the endorsement in an initial teacher preparation program, require a valid level 4 or higher certificate for admission, require an advanced level of rigor, and align the endorsement with the science of reading and GaPSC Rule 505-3-.03 FOUNDATIONS OF READING, LITERACY, AND LANGUAGE.

505-3-.100 SPECIAL EDUCATION PRESCHOOL (AGES 3-5) ENDORSEMENT - It is proposed that GaPSC Rule 505-3-.100, SPECIAL EDUCATION PRESCHOOL (AGES 3-5) ENDORSEMENT PROGRAM, dated July 1, 2021, be REPEALED and that a new rule with the same number and a different title, SPECIAL EDUCATION PRESCHOOL (AGES 3-5) ENDORSEMENT, be INITIATED. The new rule reflects the simplification and/or removal of ambiguous terms and includes updated program content standards.
