V. IN HONOR OF PAMELA GREENWAY

Chair Debbie Wilkes, Sallie Bullock, Dr. Mary Outlaw, Rose Powell and Dr. Holly Robinson, former Commissioner spoke briefly about Pam Greenway. Chair Wilkes and Sallie Bullock's comments are listed below:

Debbie Wilkes - I want to thank Kelly for the opportunity to honor Pam.

I remember the first time I met Pam. She came to her first PSC meeting at the Atlanta area RESA. She parked next to me in her silver BMW SUV and as she opened her car door the first thing I noticed was her captivating smile. Her entire face was aglow.

That was my first impression of Pam, but my respect and admiration for her grew over the time I knew her. Not only did her smile disarm you, but her ability to analyze difficult situations meant so much to me as a Commissioner and later as the Commission's Chairperson.

I, also, enjoyed having her participate on the Education Preparation Review Committee. Her perspectives as a local board member helped those of us who look at Ed Prep Programs from either a business or educational perspective.

She asked great questions and always kept us focused on the task at hand. If there were particular issues from her community, she made sure we knew about them.

In the commission meetings and especially in executive sessions when we deliberated ethics cases she was always measured, providing the lawyer and judge perspective. She understood the court proceedings and always encouraged us to look at the situation from various perspectives by using logical reasoning to help guide our decisions.

I always felt that if I needed a different perspective, I could call or email her. She was indeed one of the leaders of our Commission.

I remember the out of town trips (that we used to take). Pam, Holly, and I would "hang out", shop, and talk about our grown children. We shared the proud moments and the issues that we had with our kids. And, since her oldest was a little older than mine, she was able to share some very good advice about what to expect next!

Pam also talked about her 2 adorable grandchildren and her poodles.

She always remembered even the smallest detail that I shared with her and never failed to ask about it when I next saw her.

I remember when she told me she had breast cancer. Her determination and what I call grit helped me to understand her strength and zest for life and her belief that she could beat this disease.

I remember the last time I saw Pam. Kelly and I drove down to have lunch with her. As we sat down, before we ordered, she asked a question about a memo Kelly had emailed. She was very focused on doing what was good for children and teachers even though she was going through chemotherapy.

She loved her job, her community and her family. I will miss seeing her smiling face and her contribution to the Commission but I will never forget Pam.

Sallie Bullock- I was proud that she was the first woman lawyer in Houston County and of all 34 years she had practiced law and of her service to others which included many avenues. It gave me comfort to read what others wrote of her---of the woman's divorce she won with a smile and of her composure and wisdom as a Judge and of her wonderful family that others know, but that I have not had the pleasure of meeting. She was a fine Commissioner. Sallie spoke of the fun she had with Pam, her great style, and the contributions she made as we worked to provide the best for Georgia schools and students. Sallie confessed to the group that she emailed her during those months she was ill and could not attend our meetings with "pertinent" Commission news. She tried to make her smile with funny stories of mishaps and outfits and refreshments and sometimes embellished, but always with good intentions. It was an honor to have known her.

VI. EMPLOYEE SERVICE AWARD

Chair Wilkes presented Windy Fortenberry with a 10 Year Service Award and thanked her for her service. Kelly Henson said the following:

Windy began her work career in 1996 as a student employee with the Georgia Department of Administrative Services (DOAS). In 1997 she moved over to the Professional Standards Commission (PSC) as a temporary Receptionist and Information Specialist, and in 1999 she became a permanent PSC Information Specialist employee. In 2002 Windy was promoted to an Evaluator Trainee. Two years later she was promoted to an Evaluator II and then in 2006 she was promoted to Certification Specialist, which is the position she currently holds. She achieved all of this while attending night classes at Georgia State University where she completed a Bachelor's of Business Administration degree in Risk Management and Insurance in August 2006.

Windy is highly competent, extremely resourceful, always willing to take-on the most difficult certification cases, always eager to assist with any special projects we might have, and she ALWAYS does everything in a cheerful and friendly way. Ten years is just a beginning; she has a long and bright career ahead of her in the PSC.

B. Educator Preparation Standing Committee

Committee Chair, Dr. Craig Smith, presented the report of the Educator Preparation Standing Committee.

The Annual Report is to include a detailed plan for addressing the areas for improvement.			

Chair Wilkes Called for approval of the Educator Preparation Report as presented by Dr. Craig Smith. **PSC ACTION:** Approved

Committee members discussed the public comments submitted regarding the proposed GaTAPP Rule and

possible solutions for providing access to non-traditional pathways to clear renewable certification for private school teachers. Three suggestions were discussed and presented to the Commission for consideration:

- PSC staff will encourage The Cottage School and other private school providers to work collaboratively with the appropriate state-wide private school organizations to seek professional education unit approval as a consortium capable of offering all GaTAPP pathways to private school teachers.
- Because the process of becoming an approved unit can last approximately 18 months, PSC staff will ask RESAs to consider accepting private school teachers that do not have other viable options for gaining clear renewable certification during that time period.
- If Metro RESA is unable to serve additional program participants in The Cottage School service area, PSC staff will allow The Cottage School to offer the One-Year Supervised Practicum program to teachers in their school and to private school teachers employed outside their school for the 2009-2010 academic year and to complete the program for candidates presently in the program. PSC staff will develop the guidelines for this agreement with The Cottage School to include the Commission's expectation that all applicable standards are met.

The Commission encouraged the staff to take action on the three considerations presented to them.

VIII. EXECUTIVE SECRETARY REPORT

The Executive Secretary presented the following:

A. Kelly gave the Commissioners a copy of the Memorandum of Understanding between the Georgia Department of Education and The Georgia Professional Standards Commission. He thanked Michelle Tarbutton and Phil Blackwell for their hard work. Because the educational system in the United States is different than the educational system in many other countries, it is sometimes difficult to make a direct comparison of credentials using rules solely predicated on our system. The PSC and DOE recognize the need to create a vehicle to be used in a limited and targeted manner to provide flexibility, when needed, in making determinations regarding foreign teachers' access to Georgia classrooms. The vehicle that we have chosen is a joint MOU which must be recommended by the State Superintendent and approved by the SBOE, and recommended by the Executive Secretary and approved by the Commission. The necessary change in our rules allowing this was made several months ago by the Commission.

The first such MOU brought for your consideration is to approve an agreement between the Vienna Board of Education and the Georgia DOE. This MOU was approved by the SBOE in their meeting this month. The credentials and requirements are set forth in the MOU. In order to be considered for this program a teacher must be:

- 1) Licensed in Austria
- 2) Pass the Austrian Teacher Certification exam
- 3) Have a minimum of 3 years teaching experience

The documentation that is required is acceptable to both our certification division and DOE staff.

Teachers successfully meeting the requirements of the MOU will be eligible for an International Exchange Certificate that is valid for 1 year. If the teacher passes the required GACE tests within this year, two additional years may be added to the certificate and, at the request of an employing system, two additional years may be added.

B. Penney McRoy introduced the Educator Preparation Rules and Phil Blackwell introduced the Certification Rules to be voted on.

C. Legislative update from Kelly Henson – House Bill 280 was passed. It will start new fully-certified math and science teachers at the same salary as a fifth year teacher. Under the legislation, math and science teachers with less than five years experience will be brought up to the fifth year pay level. This bill will also encourage elementary teachers to increase their competency in math and science.

House Bill 455 was passed. This gives school systems an extra month to offer teacher contracts for next school year. Many systems are facing tight financial constraints because of the economic downturn, and the extra month will provide additional time to determine the number of teachers needed for the upcoming year. School districts now have until May 15, rather than April 15, to extend contracts and teachers have until June

1, rather than May 1, to accept their contracts. The law also extends the sunset on the Master Teacher program, and ends the additional supplement to teachers who have leadership degrees that are not in leadership positions. Current teachers with these degrees will continue receiving the supplement. Teachers currently enrolled in a leadership degree program must receive the degree by July 1, 2010, to receive the supplement until they begin a leadership position.

Senate Bill 231 (Promise Scholarship) will be alive for the next legislative session beginning in January 2010. It will be actively considered in the next session.

Senate Resolution 466 (Performance Based Principal Certification Renewal Design Team) will be alive for the next legislative session beginning in January 2010. It will be actively considered in the next session

House Bill 243 refers to the National Board Certified Teachers which eliminates the 10 percent pay supplement for any teacher not currently receiving the supplement and not currently enrolled in the National Board program. The funding allotted is approximately ½ of the current funding level.

RESA Funding – A decision was made not to incorporate RESA funding into the QBE formula funding but to maintain the current RESA funding mechanism. RESA funds were cut 3%.
