V. <u>EMPLOYEE SERVICE AWARD</u>

11. <u>STUDENT LOAN SUSPENSION / REINSTATEMENTS</u>

X. EXECUTIVE SECRETARY REPORT

The Executive Secretary presented the following:

A. Computer Skills Competency Test is a special Georgia requirement. Georgia code authorizes the PSC to implement this special Georgia requirement but it does not require us to do so. This requirement no longer serves a purpose. I spoke with many legislators as well, and they agreed that it does not commensurate with the time, effort and expense involved for educators. Rick Eiserman will introduce rules today that will remove this requirement.

MOTION: (Epps / Elkins) To notify all educators and appropriate parties of the intent of the Commission to remove the Computer Skills Competency Test as Georgia special requirement. The Executive Secretary will

waive this requirement immediately until such time as the Georgia Professional Standards Commission rule takes effect. This will also be posted on the PSC web-site.

B. Initiation of Rules – Rick Eiserman introduced rules for initiation including rules removing the Computer Skill Competency test as a special Georgia requirement. Prior to the vote, Dr. Elkins addressed clarification that changing the validity dates of the Non-Renewable Certificate from 5-years to 3-years does not include the Non-Renewable certificates in the field of Leadership (NL and NPL). The Education Leadership Rule does continue to include a 5-year validity period for the NL and NPL. The discussion portion of the current rule changes will be adjusted for clarification. Dr. Epps recommended a clerical change in 505-2-.06 to remove the (a) in paragraph (3), as an entire paragraph is being removed and there is no longer a paragraph (b).

MOTION: (Epps / Haynes) To initiate rulemaking procedures in accordance with the Georgia Administrative Procedures Act so as to provide for (1) amending the current rules in Chapter 505-2 Certification, effective July 15, 2010, as follows: 505-2-.02, 505-2-.07, 505-2-.09, 505-2-.10, 505-2-.11, 505-2-.20, 505-2-.24, 505-2-.30, and 505-2-.39; and (2) amending the current rules in Chapter 505-3 Educator Preparation, effective July 15, 2010, as follows: 505-3.01.

C. Legislative Review – A detailed legislative review chart was emailed to all commissioners on March 29th, 2010. All three PSC bills have passed the House and will cross over to the Senate (cross over day was Friday, March 26th). House Bill 1307 which would suspend PLU's for 1 certificate renewal cycle passed the House and will cross over to the Senate. House Bill 923 which extends the completion date set in last year's House Bill 455 will also cross over to the Senate.

D. Kelly Henson asked Chair Debbie Wilkes to cover the election of Commission Vice-Chair. Chair Wilkes announced that the Executive Committee met on Wednesday, April 7th at 3:30 p.m. and recommended Julia Bernath for the position of Commission Vice-Chair.
