V. EMPLOYEE SERVICE AWARDS

Chair Wilkes and Kelly Henson presented Mary Ellen Snow (5 years) and Cyndy Stephens (15 years) with their Service Awards, thanked them for their service and Kelly read the following:

Mary-Ellen Snow

Mary-Ellen has worked in the Educator Preparation Division for five years. During that time, she has served as Business Operations Specialist. In this role her work has been division-wide in providing administrative support for the entire division. Recently, she accepted the Business Manager position that will provide budgetary, administrative, planning, and technology support for the Title IIA and Educator Assessment programs. Mary-Ellen is the face of the PSC as she interacts with universities, RESAs, and school systems in fielding and responding to questions and troubleshooting problems they might experience when working with PSC processes and systems. She organizes most conference and training events; troubleshoots, develops, and refines processes that make division work run more smoothly; and solves many technology problems that never have to go to our technology staff. In addition, she is often called upon to help with agency-wide work. Mary-Ellen enjoys the challenge of solving problems that interfere with productivity and customer service. We really appreciate her contributions to the work of this agency.

Cyndy Stephens

Cyndy Stephens has worked for the Professional Standards Commission for 15 years. She is the Program Director for Recruitment and Workforce Development. The focus of Cyndy's work is on recruitment, development, and retention of teachers and leaders. She has been very successful in developing grant proposals that have been funded by the U.S. DOE. The Transition to Teaching Program is one such program that has served our state successfully for the past four years. Last year we were awarded with the largest Transition grant to a state that funds our Focus program allowing PSC and other state agencies to work with several RESAs areas in hard-to-staff parts of the state. Cyndy works nationally as an active member (and former President) of NAAC (National Association for Alternative Certification). In that capacity she has been instrumental in conceptualizing and doing some of the preliminary work in developing Quality Indicators for Alternative Preparation Programs. That work is being completed by Ohio State University and piloted in five states (Georgia is one of the pilot states). Cyndy has long been an advocate for workforce development in education, and does an outstanding job of working with other programs in the PSC as well as with other state agencies in addressing workforce issues in Georgia school systems. We really appreciate Cyndy's contributions to the work of this agency.
