# 12. STUDENT LOAN SUSPENSION / REINSTATEMENTS

The Commission reviewed the report, which indicated that there were no certificates suspended for default on repayment of student loans from March 8, 2012 through April 12, 2012. There were 6 certificates that had been *reinstated* because restitution is now being made on those student loans. There was 1 issue where notification had been received to suspend but releases were received prior to the actual suspension being implemented. Restitution is now being made on that student loan.
