The Educator Ethics Review Committee recommended to approve a no probable cause determination on 5 cases reflected on the *Applications for Certification Report*.

11. <u>STUDENT LOAN SUSPENSION / REINSTATEMENTS</u>

The Committee reviewed the Student Finance Commission Report concerning educators in which notification has been received to suspend certificates for default on repayment of student loans. The report indicated that

there were 35 certificates suspended from November 10, 2011 through December 8, 2011. The Committee was also advised that there was 1 certificate that had been reinstated because restitution is now being made on that student loan. The Committee was also advised that there were 9 issues where notification had been received to suspend but releases were received prior to the actual suspension being implemented. Restitution is now being made on those student loans.

12. FINAL DECISIONS BY OPERATION OF LAW

The Commission specifically rejected the Administrative Law Judge's determination that the educator's actions did not constitute a violation of Standard 2 of the Code of Ethics for Educators. Having reviewed the entire record, after hearing argument from both sides, and giving due regard to the recommendation of the Administrative law Judge, the Commission rejected the Initial Decision of the Administrative law Judge. The Commission concluded that a greater sanction was appropriate in this particular case because the reprimand recommended by the Administrative Law Judge did not reflect the seriousness with which the Commission views the educator's violation of rules applicable to educators. The Commission further acknowledges that many educators return to the profession thus a suspension would not be meaningless. The Commission ordered that the Georgia educator certificate held by Patricia Cummings be suspended for a period of twenty consecutive contract days to be served retroactively effective September 1, 2011 ending September 29, 2011.
