I. WORK SESSION

- A. Kelly Henson announced that this was Dr. David Hill's last Commission meeting. He thanked him for his service and many staff members and Commissioners spoke briefly about the impact that David has had on education in Georgia. He reminded everyone that in January the General Assembly will be in town and thanked Kristina Stroede for periodic updates. He recognized Linda Fortson, the Fortson Law Office, and thanked her for being at almost every Commission meeting for the past 10-11 years. Linda Fortson then spoke briefly about her work with the Commission. Kelly reminded the Commission that he will miss the January Commission meeting and that Dr. Paul Shaw will take his place.
- B. Anne Marie Fenton presented the rules to preview. Penney McRoy gave a power point on 505-3.02 Preparation Program Effectiveness Measures and Kelli Young provided a hand-out on the certification rules 505-2-.04 Induction Certificate, 505-2-.18 Paraprofessional License,505-2-.23 Certificate of Eligibility, 505-2-.43 Annual Performance Evaluation, 505-2-.87 Healthcare Science, and 505-2-.90 Career and Technical Specialization
- C. Anne Marie Fenton presented the rules for adoption, with an effective date of January 15, 2017: 505-3-.01 REQUIREMENTS AND STANDARDS FOR APPROVING EDUCATOR PREPARATION PROVIDERS AND EDUCATOR PREPARATION PROGRAMS It is proposed that GaPSC Rule 505-3-.01, REQUIREMENTS AND STANDARDS FOR APPROVING EDUCATOR PREPARATION PROVIDERS AND EDUCATOR PREPARATION PROGRAMS, dated October 15, 2016, be AMENDED to clarify rule language related to requirements for program admission, assessment, and field and clinical experiences and related reporting. At the request of program providers, the requirement for program completers to submit the GaPSC-administered Completer Survey prior to the verification of certification eligibility is being removed. The Completer Survey is not a component of Preparation Program Effectiveness Measures (PPEMs) and is administered by GaPSC solely for the purpose of supporting program provider efforts to gather perception data that may inform program improvement. 505-3-.05 GEORGIA TEACHER ACADEMY FOR PREPARATION AND PEDAGOGY (GaTAPP) It is proposed that GaPSC Rule 505-3-.05 GEORGIA TEACHER ACADEMY FOR PREPARATION AND PEDAGOGY (GaTAPP), dated October 15, 2016, be AMENDED. This amended rule allows candidates holding an Induction Pathway 2 or Induction Pathway 3 Certificate to enter an Early Childhood Education Certification-only Program through

GaTAPP. Also candidates in this ECE Certification-only program are no longer required to obtain a Professional passing score on the Georgia state approved content assessment for Early Childhood for program completion.

As a reminder, the Ethics Rule 505-6-.01 Code of Ethics for Educators, that you adopted on September 14, 2017, will become effective January 1, 2018. The changes in the rule to consolidate the standards from eleven (11) to ten (10), including eliminating abandonment of contract as a separate standard, and adding the definition for breach of contract.

- D. Dr. David Hill gave a presentation titled University Principal Preparation Initiative which was an update for the Commission on UPPI work in Georgia.
- E. Nathan Estel, Director of Educator Relations, Evaluation Systems group of Pearson (ES), shared an update on national adoption of edTPA and thanked GA for serving as a model for other states toward educative implementation. He presented edTPA performance data comparing GA to the rest of the nation for GA's first two years of consequential use of edTPA. Anne Marie Fenton then shared the aggregate mean scores of state-approved EPPs (not identified), as well as fall 2017 available data for the 15 rubric and 18 rubric handbooks. Information about the Feb. 6-7 GaPSC edTPA EPP and P-12 Summit was also shared.
- F. Chair Luigs also recognized Linda Fortson and thanked her for all the good work that she has done on behalf of Georgia educators. She wished everyone a Merry Christmas, Happy Chanukah and Happy holidays to all as it is the season of holidays.
