VII. EXECUTIVE SECRETARY REPORT

The Executive Secretary presented the following:

A. NASDTEC (National Association of State Directors of Teacher Education and Certification) Interstate Agreement – An Agreement (not a binding contract) between jurisdictions to recognize comparability of selected, professional certification/licensure. This agreement is renewed every five years.

<u>MOTION</u>: (West / Thompson) The Professional Standards Commission to re-sign the Interstate Agreement with all states, the District of Columbia and the DOD Educational Activity for traditional and alternative routes in all categories.

ACTION: Approved

B. A map of Georgia was given to the commissioners highlighting the areas where commissioners reside.

C. Information about the National Board of Certified Teachers and the systems in which they are employed was distributed. Dr. Toth informed the commissioners that legislation was considering an amendment to Senate Bill 34, which will require the National Board of Certified Teachers be employed in high needs schools to continue receiving their 10% bonus.

D. Approval of Revised Praxis Scores Based on Score Review – Cathy Smiley, Education Staff Specialist, distributed information on the new revised Praxis scores. Educational Testing Services recommends that scores be reviewed every 5-7 years. PSC convened panels of practicing Georgia teachers and teacher-educators to review and recommend scores for sever Praxis tests.

MOTION: (Slack / West) To approve the new recommended scores for the Praxis tests.

ACTION: Approved

Effective March 15, 2004, PSC passed new certification rules. One of the new rules allows individuals who hold clear renewable certificates in teaching fields, to pass Praxis II tests to add other teaching fields to their certification. New certification rules and NCLB make it necessary to provide many alternatives to becoming certified and highly qualified. An "assessment alternative" gives teachers another option to show that they are "highly qualified" as well as fully certified. PSC convened panels of practicing Georgia teachers and teacher-educators for the purpose of reviewing and setting scores for several new Praxis tests. A passing score was defined as the minimum score that a candidate needs to achieve on the test in order to meet Georgia requirements. The passing score reflect the minimum level of knowledge and/or skills that an entry-level teacher needs to demonstrate in order to be considered ready to engage in professional practice.
