There were 4 issues where notifications had been received to suspend but releases were received prior to the actual suspension being implemented. Restitution is now being made on those student loans.

# 13. FINAL DECISIONS BY OPERATION OF LAW

The Commission reviewed the report, which advised of 6 cases now closed without an appeal for a hearing before an Administrative Law Judge. The report also advised that there were no cases closed without an appeal for a review hearing before the Commission.

Judge Magnum confirmed that the commission does receive the entire record.

MOTION: (Muns / Bradley) The findings of fact found by the Administrative Law Judge as indicated in the Initial Decision were hereby rejected. Based on a review of the record, the following facts were hereby adopted and incorporated herein: 1. Harold Oberg is employed as a high school Science teacher by the Savannah-Chatham County School System. 2. On or about August 16, 2005, Oberg claimed he had earned a Ph.D. from a "LaSalle University" in Louisiana when he completed an electronic application for Georgia educator certification. 3. The educator listed different dates of attendance on his applications for employment and for certification. Both sets of dates are inconsistent with the dates listed on his "transcript" from LaSalle University. He listed dates of attendance as April 1996 - May 2002, on his school system application. (PSC Ex. 1, p. 5). On the PSC application, the dates listed were May 2000 – May 2002. (PSC Ex. 2, p. 25). However, the official transcript he submitted showed dates of July 7, 1999 – September 15, 2000. (PSC Ex. 2, p. 27). 4. The Certification Operations Manager for the Commission testified that the Commission depends on the Council of Higher Education Accreditation and U.S. Department of Education for their accreditation standards. LaSalle University of Louisiana is not an accredited school and is not recognized by the Georgia Professional Standards Commission. 5. Mr. Oberg was erroneously certified as an L7 and thus entitled to a higher salary, which he received until the error was corrected. 6. Mr. Oberg testified that the courses listed on his LaSalle transcript were actually transfer credits from coursework he completed approximately 18 years earlier at other institutions. (PSC Ex. 2, p. 27; Tr. 75, 78-84, 101, 110). He could not explain why his classes from other institutions had "transferred" to LaSalle with a higher grade than he earned at the other institutions. (Tr. 108). 7. Mr. Oberg testified that he began work on a formal dissertation after 2000 and completed a "verbal" exam via the telephone. He produced some handwritten notes on notebook paper and claimed that these notes constituted his dissertation but that he had not actually completed a written paper. (Petitioner's Ex. 6; Tr. 84, 120). 8. The educator agreed that one could make a reasonable assumption that someone looking at the LaSalle University transcript would believe that he actually took the courses listed, during the dates listed, for the grades listed. He also agreed that he knows a dissertation is a formal paper done in writing and presented at school. (Tr. 105, 109). 9. Oberg was aware that he had not completed a dissertation and nonetheless received a Ph.D. from LaSalle. There were other indications to him that his degree was illegitimate and that LaSalle was not an acceptable institution from which to receive a degree. Nonetheless, he submitted his

application listing the degree and thereafter received pay at an elevated level based on a certificate level which he had not legitimately attained.

The Conclusions of Law found by the Administrative Law Judge as indicated in the Initial Decision were hereby rejected. Based on a review of the record the following conclusions are hereby adopted and incorporated herein: 1. The Commission has adopted a code of ethics for educators, which represent standards of performance and conduct which are generally accepted by educators of this state. O.C.G.A. § 20-2-984.1(a). Educators of this state are required to abide by such code of ethics. O.C.G.A. § 20-2-984.1(b). The code defines unethical conduct justifying disciplinary sanction. PSC Rule 505-6-.01(1). 2. If the Commission finds that there is probable cause for imposing a sanction against the educator, it may recommend any combination of the following: That the educator be warned, reprimanded, monitored or any combination thereof; or That the certificate of the educator be suspended, revoked, or denied. O.C.G.A. § 20-2-984.5(c). 3. Standard 4 of the Code of Ethics for Educators provides in part that: An educator should exemplify honesty and integrity in the course of professional practice. Unethical conduct includes but is not limited to: falsifying, misrepresenting, omitting or erroneously reporting professional qualifications, criminal history, college or staff development credit and/or degrees, academic award, and employment history when applying for employment and/or certification or when recommending an individual for employment, promotion, or certification. Commission Rule 505-6-.01 (3) (d). The Commission found probable cause to believe Mr. Oberg falsified, misrepresented, or erroneously reported his Ph.D. from LaSalle University in Louisiana when he applied for employment and certification since LaSalle was not an accredited school and is not recognized by the Commission. 4. Standard 5 of the Code of Ethics for Educator provides that: An educator entrusted with public funds and property should honor that trust with a high level of honesty, accuracy, and responsibility. Unethical conduct includes but is not limited to: submitting fraudulent requests for reimbursement of expenses or for pay. Commission Rule 505-6-.01 (3) (e). The Commission found probably cause to believe Mr. Oberg violated this standard when he misrepresented his qualifications to obtain a doctorate level certification and receive higher pay than he should have earned. 5. Standard 10 of the Code of Ethics for Educators provides that: An educator should demonstrate conduct that follows generally recognized professional standards. Unethical conduct is any conduct that impairs the certificate holder's ability to function professionally in his or her employment position. Commission Rule 505-6-.01 (3) (j). The Commission found probable cause to believe Mr. Oberg failed to follow generally recognized professional standards when he misrepresented his educational credentials, thus affecting his ability to function in his employment position as parents and the school system can have no confidence in a teacher who cheats to get his doctorate degree by buying it online.

The Commission hereby rejects the modified sanction recommended by the Administrative Law Judge as indicated in the Initial Decision. The Commission concludes that a greater sanction is appropriate in this particular to be consistent with sanctions given in similar cases. The Commission hereby ORDERS that the Georgia educator certificate held by Harold Oberg be suspended for one year effective February 29, 2008 through March 1, 2009. If the Respondent decides to appeal this decision, he/she must file a petition within 30 days after service of this Final Decision pursuant to O.C.G.A. § 50-13-19. **PSC ACTION**: Approved

# IX. EXECUTIVE SECRETARY REPORT

**A.** Kelly Henson told the commissioners that at the last Alliance of Education Agency Heads meeting he was asked to chair a task force on increasing the number of math and science teachers in Georgia. They would like

to have a qualified teacher in every classroom. Their goal is to increase the pool of math and science teachers. They will be looking at different solutions and will take an aggressive approach in solving this problem. The goal is for this task force to compile their work and present findings and recommendations to the Alliance and the Governor by the end of June.

**B.** Kelly Henson passed out the PSC's new brochure titled "Safeguarding Georgia's Students and Standards". He announced that the PSC is working to enhance the image and branding recognition and information from the PSC. Rick Eiserman and Chuck McCampbell are working with a group of PSC staff members on redesigning our website as well.

**C**. Kelly Henson shared with the commission pictures that were taken at the Joint Education Boards Liaison Committee (JEBLC) reception which was held on January 28<sup>th</sup>. Dr. Debbie Wilkes spoke briefly about the JEBLC meeting and reception which the PSC hosted. She thanked Rick Eiserman, John Grant and Renee Shaat for their help in making sure that the meeting and reception ran smoothly. She also thanked Maria Miller for chairing the meeting and she thanked all the commissioners that attended the reception.

**D.** Kelly Henson gave the commission a brief a overview of personnel changes. Phyllis Payne was moved from Education Staff Specialist – Master Teacher to Education Staff Specialist – Alternative Certification on February 1st. Ginny Elliott will be moved from Education Staff Specialist – Master Teacher to Master Teacher Program Director and Dr. Winifred Nweke will be moved from Research and Evaluation Coordinator to Education Staff Specialist – Master Teacher on February 18th. We will be interviewing for the Program Director for Testing position on February 15th and hope to choose a candidate. We also hope to hire a Director of Management and Business Operations within the next couple of weeks. We will work to gather additional information on the visually impaired workforce and provide that information to the legislative sub-committee.

Gary Walker is working with Representative Howard Maxwell to point out conflicts in the law regarding Educator Ethics.

Jerry Eads, Chuck McCampbell and Kelly Henson will meet with Representative Brooks Coleman at the capitol today after the commission meeting to present data on teacher workforce.

Representative Brooks Coleman and others have introduced House Resolution 1103. It calls for creating the Joint Study Committee on Teacher Training and Certification. We look forward to sharing the excellent work that is both a part of the Certification Division and Educator Preparation Division. We all share the goal of a qualified teacher in every classroom. It is my hope that House Resolution 1103 will help us achieve that goal.

F. Kelly Henson thanked Jane Huntley, Phyllis Payne and Ginny Elliott for their work on Master Teacher. He also

thanked Governor Perdue and others involved for the tangible reward for that meet the Master Teacher requirements.

A Master Teacher that mentors another teacher will receive an annual stipend of \$500.00. A Master Teacher that serves as an Academic Coach will receive an annual stipend of \$2,000.00. If a teacher maintains their Master Teacher status he/she will receive automatic renewal through the PSC, and all other education agencies will look to the Master Teacher list when appointing teachers to boards, task forces, and committees.

G. Phil Blackwell presented the certification rules for initiation.

**H.** Dr. David Hill presented the Georgia Assessments for the Certification of Educators (GACE) Preliminary Pass Rate Analysis – by Group for the Computer Skills Competency Assessment and test pass rate analysis and interpretive notes.
