#### 12. **REVIEW HEARING EXTENSIONS**

The Commission reviewed the *Review Hearing Extensions Report* concerning 3 hearing cases. An Administrative Law Judge rendered Initial Decisions on each case referenced in the report. The report indicates Orders were issued.

#### 13. STUDENT LOAN SUSPENSION / REINSTATEMENTS

made on those student loans. There were 8 issues where notification had been received to suspend but releases were received prior to the actual suspension being implemented. Restitution is now being made on those student loans.

**MOTION**: (Powell / Jennette) The PSC rejected the Initial Decision and found as follows: FINDINGS OF FACTS - A.M. stated in class that she wasn't a "guy". The Educator replied "we haven't taken a shower together yet". Tr. 64. The Educator allowed other detrimental remarks to be made about A.M. Tr. 44 and 64. It was alleged that Educator picked A.M. up to his shoulders and spun her around. This allegation was supported by Educator's admission and other testimony in the record. Tr. 12, 50. Although Educator stated he did this in an effort to break up a fight, student J.J. testified Educator did this for "fun" and that there was no fight. Tr. 50. It was alleged that Educator pulled A.M. in between his legs. This allegation was supported by the testimony of A.M. and the admission of Educator. Tr. 12, 64. It was alleged that Educator frequently rubbed A.M.'s shoulders. This allegation was supported by the testimony of the victim. Tr. 63. It was alleged that Educator hugged A.M. Educator admitted this to D.F.. Tr. 12. Student H.P. also testified to this. Tr. 28. It was alleged that Educator called A.M. "Pinky" because he had seen her underwear once and it was pink. This allegation was supported by the testimony of the victim. Tr. 63. Educator admitted that he had seen the student's pink underwear on one occasion. Tr. 76. Educator also admitted that he called A.M. "Cupcake." Tr. 63, 114. It was alleged that Educator frequently held private conversations with A.M. apart from the other students in class. This allegation was supported by testimony from student H.P. and the victim. Tr. 28, 64. Student witnesses also reported that Educator and A.M. had a close relationship or that they thought that something was going on between student and teacher. Tr. 29, 46. A.M. sat in Educator's lap on a few occasions. Tr. 129, 117. It was alleged that when A.M.'s complaints became known to Educator, he called her home, spoke with her father telling him that A.M. was a lesbian who had just "broken up" with student "V." This was supported in the record by the testimony of K.M., A.M.'s father. Tr. 53. Educator admitted that he called A.M.'s father to discuss the statements that A.M. was making about him. Tr. 119. Educator's daughter, H.H., testified that she learned of A.M.'s allegations about her father from "V" who was a good friend of A.M. and in whom A.M. had confided. Tr. 101. It was Educator's phone call to K.M. which led to A.M.'s allegations being made known to school administrators. Tr. 103, 104, 10, 67. In fact, A.M. made no outcry, but instead her parents reported the situation to school system administration. Tr. 103, 22, 11. Educator, however, later discussed the matter in front of other students. Tr. 50, 97. A.M. was made uncomfortable by Educator's

behavior toward her. Tr. 25. She also was negatively affected by what happened both before and after Educator's actions became known. Tr. 80-82.

CONCLUSIONS OF LAW - The record shows that Educator violated Standard 2 of the Code of Ethics for Educators. He hugged A.M., called her nicknames, picked her up, pulled her into his lap, and engaged in private conversations with her. As such, Educator failed to maintain a professional relationship with A.M., engaged in harassing behavior towards her and engaged in an inappropriate relationship with her. The record further shows that Educator violated Standard 10 of the Code of Ethics for Educators. Again, Educator hugged A.M., called her nicknames, picked her up, pulled her into his lap and engaged in private conversations with her. Further, Educator called A.M.'s father and attempted to cast aspersions on her at a time when her complaints were becoming known. Educator also discussed this matter with other students. As such, in this situation Educator failed to follow generally recognized professional standards. Further, Educator was unable to function professionally when the allegations became known. Educator engaged in a pattern of behavior which was detrimental to the health, welfare discipline and morals of A.M. and other affected students. DECISION -Having reviewed the entire record, after hearing argument from both sides, and giving due regard to the recommendation of the Administrative Law Judge, the Commission hereby rejected the Initial Decision entered in this matter. In so doing, the Commission noted that some of the facts relied upon by the ALJ were not supported by the record. The Commission concluded that a sanction is appropriate in this particular case because a No Probable Cause finding as recommended by the Administrative Law Judge does not reflect the seriousness with which the Commission views the Educator's violation of the rules applicable to educators. The Commission hereby ORDERED that the Georgia educator certificate held by BRIAN HACKETT shall be SUSPENDED for a period of 90 Contract Days to begin February 23, 2009 and shall conclude September 8, 2009.
