The Commission hereby adopts paragraphs 1-2 and 6-7 of the Findings of Fact in their entirety. 2. The Commission hereby deletes the word "theoretically" from the third sentence of paragraph 3 of the Findings of Fact. 3. The Commission hereby revises paragraph 4 of the Findings of Fact to state as follows: The Petitioner testified that in 1993, after he submitted his Application for Evaluation to the Commission, he received an envelope in the mail from the Commission that contained his Application for Evaluation and transcripts, as well as a letter from the Commission evaluating his credentials. The Petitioner testified that in 1995, he attempted to obtain his Educator's certificate; however, he was unable to locate the evaluation letter he received from the Respondent in 1993. Although he was unable to locate the Commission's letter, he did locate and produce his original Application for Evaluation and transcripts, which arrived in the same envelope as the Commission's letter. Therefore, in July of 1995, he testified that he contacted the Respondent and requested a copy of the 1993 letter. The Petitioner's mother testified that she opened the envelope and examined the letter before giving it to her son. She identified the July 12, 1995 letter, admitted into evidence as PSC Ex. 2, as the letter her son received on that occasion. The Petitioner also testified that he received PSC Ex. 2 in an envelope from the Respondent and that he neither falsified the letter nor had reason to believe it was falsified by someone else. (Test. of Petitioner, t. 92-95, 101, 103, 116-117; Test. Mary Alice Moore, t. 127-128.) 4. The Commission hereby revises the first sentence of paragraph 5 of the Findings of Fact to state as follows: By 1998, the Petitioner had completed all of the requirements for certification contained in the letter he purportedly received from the Respondent in 1995, except the requirements for student teaching.

The Commission hereby revises the first sentence of paragraph 8 of the Findings of Fact to state as follows: The July 1995 letter which the Petitioner purportedly received from the Respondent contained the following irregularities which made the Respondent conclude that the Petitioner had forged it: 6. The Commission hereby adds a new paragraph 9 to the Findings of Fact that states as follows: Belinda LaFavor testified at the hearing that she did not create or send the July 1995 letter that appears to bear her signature. This testimony is credible in light of the independent corroborating evidence set forth in paragraph 8, above. In addition, the Commission did not maintain records of Applications for Evaluation in 1993, and therefore could not have provided the Petitioner with a copy of its 1993 letter. (Test. of Belinda LaFavor, t. 145-146.)

The Commission hereby adopts the Administrative Law Judge's Conclusions of Law, with the following revisions: 1. The Commission hereby adopts paragraphs 1-5 of the Conclusions of Law in their entirety. 2. The Commission hereby revises paragraph 6 of the Conclusions of Law to state as follows: The Commission finds that the Petitioner failed to prove by a preponderance of the evidence that he did not knowingly submit a falsified document to the Commission. The Commission finds that the Petitioner either forged or altered the July 1995 letter himself, or presented it to the Commission with the knowledge that it was forged or altered. The Commission's conclusion is based on the uncontroverted evidence, as set forth in paragraph 8 of the Findings of Fact, as well as on the following: The Commission gives due regard to the ALJ's finding that the testimony of the Petitioner and his mother was credible. However, the Commission bases its decision on specific and uncontroverted evidence in the record. For example, the Petitioner testified that he received the letter at issue, which was dated July 12, 1995 and purportedly written by Belinda LaFavor, in July of 1995. However, the uncontroverted evidence at the hearing established that Margaret Torrey, whose name was on the letterhead as the Commission's Executive Secretary, did not take that office until July 1, 1996. Therefore, an individual writing the letter in 1995 would not have placed her name on the letterhead. This evidence suggests that the "July 1995 letter" was actually written sometime after Margaret Torrey became the Commission's Executive Secretary, in July of 1996, and that the Petitioner and his mother falsely testified that they received the letter in 1995. Given that the Petitioner did not present the letter to the Commission until 1998, the evidence supports the conclusion that the Petitioner either forged or altered it himself, or presented it to the Commission with the knowledge that it was forged or altered. The Commission also questions the testimony of the Petitioner's mother, in that she testified that she remembered the specific contents of a letter she saw in 1995 and did not see again until 1998. 2. The Commission finds the Petitioner's testimony that he had misplaced the 1993 evaluation letter he received from the Commission to be unlikely, given that he kept and produced the 1993 Application for Evaluation and transcripts, which were returned to him in the same envelope with the 1993 evaluation letter. 3. The Commission notes that the Petitioner provided only a copy of the July 1995 letter, not the original, and that alteration of a copy of a document is easier to achieve than alteration of an original document. 4. The Commission is concerned that the ALJ may have misapplied the burden of proof in this case. Although the ALJ correctly recited that the burden of proof was on the Petitioner, his analysis indicates that he improperly placed the burden on the Commission. The ALJ found that the Commission's case was "significantly weakened by its failure to present a motive for the Petitioner's alleged actions." However, the ALJ did not impose a similar requirement on the Petitioner to prove a motive behind the Petitioner's theory that the Commission had produced the falsified letter. Given that the ALJ also found the Petitioner's theory unpersuasive, he should have found that the Petitioner failed to carry the burden of proof.

The Decision of the Administrative Law Judge to REVERSE the Professional Standards Commission's proposed sanction to Deny the educator's a Georgia educator certificate and that no action be taken is hereby *Rejected*. The

Commission concludes that a sanction is appropriate in this particular case because a No Probable Cause determination is not supported by the actual record in the case. The Commission hereby **ORDERS** that the Application for a Georgia educator certificate be allowed to proceed with a Reprimand being issued.

VIII. EXECUTIVE SECRETARY REPORT

A. Dr. Toth presented an Article entitled "Governor Perdue Announces 2005 Georgia Learns Education Package" which was given to the commissioners.

B. Dr. Toth announced that he and Dr. Gary Walker, Director of Educator Ethics, met with Stefan Ritter of the Attorney Generals Office concerning the PSC's representation. They will come back to the commission with recommendations. Mr. Ritter was present at this commission meeting and Dr. Toth introduced him.

C. Dr. Toth gave each of the commissioners a copy of "Alternative Routes to Teacher Certification" and "Increasing the Odds – How Good Policies Can Yield Better Teachers". The Georgia TAPP program received national recognition in "Alternative Routes to Teacher Certification".

D. Dr. Toth gave the commissioners 3 pieces of legislation (LC 33 0567-EC, LC 33 0576-EC, LC 33 0577-EC) on the Master Teacher plan.

E. "Praxis Scores Comparisons by State" and "Background and Discussion on the Approval of Revised Praxis Scores Based on Score Reviews" were given to the commissioners for their review. ETS recommends that we review our Praxis scores every 5-7 years. The commission should be prepared to vote on this issue at our next meeting.

F. 505-6 Chapter of the Educator Ethics Rules
