11. APPLICATIONS FOR CERTIFICATION REPORT

VII. <u>RULES</u>

Anne Marie Fenton presented the certification and educator preparation rules. She stated that the chair that led the work on the revisions to 505-3-.23 Health and Physical Education Program rule, which became effective December 10, 2010, had requested a change in numbering. Ms. Fenton provided the Commissioners at copy of the 505-3-.23 Health and Physical Education Program rule with the change in numbering highlighted, and stated that the Secretary of State's (SOS) office advised and offered that the change in numbering be made by the SOS's office. No action is needed on the part of the Commission for this change.

as follows: 505-2-.20, 505-2-.38, and 505-2-.252; (2) initiating the current rules in Chapter 505-2 Certification, effective October 15, 2011, as follows: 505-2-.208 and 505-2-.209; (3) amending the current rules in Chapter 505-3 Educator Preparation, effective October 15, 2011, as follows: 505-3-.83; and (4) initiating the current rules in Chapter 505-3 Educator Preparation, effective October 15, 2011, as follows: 505-3-.53, 505-3-.54, and 505-3-.59.

VIII. EXECUTIVE SECRETARY REPORT

Commissioner Meredith Hodges requested a discussion on the upcoming CRCT cases. She also suggested that the entire Commission discuss the framework of how the cases will be handled. Kelly Henson and Rebecca Mick, Counsel for the PSC, addressed the Commission.

Kelly Henson stated that we should have most cases to the Commission in September to determine if we should investigate. We anticipate receiving approximately 178 cases. Every case has its own set of facts, however, we can exercise grouping and look at precedent. The evidence should be attached to each individual case. We must prove if cheating occurred and if it did we must link the cheating to an educator. We must prove that it was more likely than not that it did occur in order to move the case forward. If a district investigated a case and did not find fault, we do not have to rely on this. We will schedule a meeting of the entire Commission in September to lay boundaries on how to move forward with the CRCT cases.

Rebecca Mick (PSC legal counsel) said that she is expecting the complaints in groups e.g. Superintendents, Principals, Vice Principals. She suggested that we might consider giving a lesser sanction to educators who confessed versus those that did not and educators who helped investigators implicate educators who held higher positions; and c) etc. Once we receive the complaints we can begin to set up parameters.
