I. CALL TO ORDER

Chairman Culbreath called the meeting to order at 9:10 a.m. and led the assemblage in the Pledge of Allegiance to the U.S. flag and a moment of silence.

At this time, Dr. Sue Sehgal introduced our host, Mr. Peter White of the Southern Center for International Studies, to the Commission. Mr. White gave a short summary of the history and mission of the SCIS and welcomed all those in attendance.

II. RECOGNITION OF VISITORS

Chairman Culbreath recognized the visitors.

III. ADOPTION OF AGENDA

Chairman Culbreath called for approval of the agenda with three changes. The hearing for Mr. Joe Moore will be held at 9:30 a.m., the hearing for Ms. Sonja Floyd will be at 1:00 p.m., and the Executive Secretary's report will be done in segments during the day, as time allows.

MOTION: (Wallace/Sehgal) To adopt the agenda as amended.

ACTION: Approved.

IV. <u>APPROVAL OF MINUTES</u>

Chairman Culbreath called for approval of the minutes from the May 3, 2001, Commission meeting.

MOTION: (Cribbs/Finn) To approve the minutes as written.

ACTION: Approved.

V. EXECUTIVE SECRETARY'S REPORT

A. Dr. Toth asked Dr. Fran Watkins, Director of Educator Preparation, to talk to the Commission about the reasons for recommending the acceptance of a composite score for Praxis I. After considering the proposal, the following motion was made.

MOTION: (Wallace/Cribbs) To approve the recommendation to accept the total current minimum as a composite score for anyone taking the Praxis I on or after March 1, 1999. (PPST - 526; CBT - 964) **ACTION:** Approved.

A. Joe Moore - Case No. 99-12-772 (9:30 a.m.).

Robin Frazier Clark, PSC Hearing Officer, gave Mr. Moore's attorney, Ms. Joyce Griggs, and PSC's attorney, Rebecca Mick, each 20 minutes to present oral arguments.

MOTION: (Sehgal/Cribbs) To go into executive session to make a decision in this case, and to allow the PSC attorney, Kendall Kerew, the Director of Professional Practices, and the commission's two legal secretaries to remain with the commission during its deliberation.

ACTION: Approved.

Return to open session.

MOTION: (Sehgal/Hurley) To uphold the decision of the Administrative Law Judge (Reprimand and

Monitoring for Eighteen Months).

ACTION: Approved

B. Richard Eason - Case No. 99-10-510 (10:15 a.m.).

Robin Frazier Clark, PSC Hearing Officer, gave Mr. Eason's attorney, Mr. Jerry Thomas, opportunity to speak to the Commission, at which time Mr. Eason's application for a review was withdrawn. The initial decision of *Revocation* now becomes the final decision by operation of law.

VII. COMMITTEE REPORT

A. <u>Professional Practices Review Committee</u>

After a preliminary review of the Professional Practices Review cases, the Commission decided to go ahead with the remainder of the Executive Secretary's Report.

V. EXECUTIVE DIRECTOR'S REPORT (continued)

B. Rick Eiserman, Director of Certification, was asked by Dr. Toth to review the eligibility requirements for the intern certificate (teaching fields only) that will be used in the Teach for Georgia program. The Intern Certificate holder will be paid at the provisional certificate level and the certificate will be transferable from one system to another. After discussing the recommendations for initial certification and requirements to be met during the Teach for Georgia Program, the following motion was made.

MOTION: (Wallace/Cribbs) To adopt the written recommendations regarding the certification process of the Teach for Georgia Alternative Preparation Program.

ACTION: Approved

Abstentions: None

C. Dr. Toth recommended that the Commission add Praxis I as a requirement for Provisional certification. This would not take the place of the Praxis II, but would be an added requirement.

<u>MOTION:</u> (Bailey/Melton) To adopt the recommendation to add Praxis I to the already established requirements for provisional certification. Praxis II remains a requirement. **ACTION:** Approved.

D. Executive Secretary Toth also recommended that the Commission allow applicants who have gone through an approved Georgia Educator Preparation Program to be recommended by their college when they have completed all certification requirements except passing the Praxis II examination. These students would be eligible for a one-year conditional certificate, during which time they must pass Praxis II. This would give Georgia students the same length of time to pass their test as we already give out-of-state graduates. This would apply to applicants in all Georgia education programs. (Leadership, Service, or Teaching).

MOTION: (Bailey/Melton) To adopt the recommendation with stipulations as noted. **ACTION:** Approved.

E. Dr. Toth reported that for many years it has been Georgia's practice to issue a P-8 certificate in Elementary Grades, if a teacher came to Georgia with an Elementary Grades Certificate from another state. It is his recommendation that the Commission rescind Certification Rule 505-2-.62, to eliminate

the Elementary Grades certificate entirely by March 1, 2002. Georgia would continue to honor all existing certificates in Elementary Grades until each individual's next renewal date. At that time, all persons (whether coming from outside Georgia or already certified in Georgia) with an Elementary Education certificate would be required to choose between Early Childhood and Middle Grades, but would be allowed to request an evaluation in the second field. If their choice is Middle Grades Education, they would also need to show evidence of at least two concentrations.

<u>MOTION:</u> (Hurley/Cribbs) To initiate rule-making to rescind Professional Standards Commission Rule 505-2-.62, and to begin the process of having existing Georgia Elementary Grades teachers choose at their next renewal date whether they wish to be certified in Early Childhood Education or Middle Grades Education, but allowing them the opportunity to request an evaluation in the second field.

ACTION: Approved.

Those opposing as well as those in agreement with the rules were given ten minutes each to express their views and concerns to the Commission.

The proposed changes were taken under advisement until the Commission's next meeting scheduled for July 12, 2001, or a possible conference call.
