The Georgia Professional Standards Commission (PSC) met on Thursday, June 14, 2018.

I. WORK SESSION

- Executive Secretary's Report
 - a) Kelly Henson welcomed Scott Hollowell to the Commission. Scott is Vice Chair of Fayette County Board of Education and Principal Financial Advisor of Hollowell Financial Group. He is a member of the Fayette Chamber of Commerce and has sat on the boards of directors for Advo-Kids CASA and Friends of the Tyrone Library. Scott earned a bachelor's degree in Communication from Ohio University and a master's degree from the University of Georgia.
 - b) Staff member from the Educator Preparation, Certification and Educator Ethics divisions attended the annual NASDTEC conference held in Minneapolis, Minnesota in June and gave presentations. Anne Marie Fenton was presented with the Distinguished Leadership Award.
 - c) Chris Erwin is a Republican candidate for District 28 of the Georgia House of Representatives. The primary election took place on May 22, 2018. The general election is being held on November 6, 2018. Chris Erwin (R) is unopposed in the Georgia House of Representatives District 28 general election.
 - d) Dr. Isiah Hill won his 6th State Championship in Track and Field.
 - e) Katrina Young was elected as President of the Georgia School Board Association in Savannah at their annual summer conference.
 - f) Amanda Miliner was MC at the Miss Georgia pageant held in Columbus, Georgia. She is a former Miss Georgia.
- Standard Setting for three GACE Service Fields Anne Marie reviewed GACE data for three service field assessment (Media Specialist, School Counselor, and School Psychologist). The following recommendation to adjust the passing standard was provided: To change the passing scores for the Media Specialist, School Counselor, and School Psychologist assessments in a manner that is consistent with all teaching field content assessments.
 - a) Beginning with score reports dated on or after September 1, 2019, the Induction passing score (235 GACE scale) will be equal to minus 1 CSEM below the Recommended Study Value (RSV) established by the Georgia standard setting committees.
 - b) The Professional passing score (250 GACE scale) will remain the RSV.

- GACE Computer Science Standard Setting Anne Marie reviewed the recommendations from an expert panel of Georgia educators who reviewed the GACE Computer Science assessment and confirmed that the recommendation from the multistate standard setting was appropriate for beginning Georgia computer science teachers. The following recommendation to establish the passing standard for this assessment was provided: To formally establish the following passing scores for the Computer Science assessment (test code 555), beginning with the October 2018 launch of the test: the Professional passing score (250 GACE scale), which equals the Recommended Study Value (RSV) of 47 raw score points, and the Induction passing score (220 GACE scale), which equals the RSV minus 2 CSEM (39 raw score points), until score reports are issued dated on or after September 1, 2019, when the induction passing scores for all teaching field content assessments are raised. Beginning with score reports dated on or after September 1, 2019, the Induction passing score (235 GACE scale) will equal the RSV minus 1 CSEM (43 raw score points).
- Anne Marie introduced the preview of rules to come before the Commission for their consideration to initiate on July 12, 2018. Kelli Young previewed the Certification Rules and Penney McRoy previewed of the Educator Preparation rules, as follows:

- Teacher Leader Task Force The Teacher Leader Task Force is comprised of a variety of principals, teacher leaders, central office personnel and teacher leader providers. This task force is under the direction of Penney McRoy and is being facilitated by Paquita Morgan and Bobbi Ford in collaboration with the DOE and GLISI. The goal of the task force is to create a belief statement to provide direction for teacher leadership in Georgia as well as create a Teacher Leadership Toolkit to support the advancement of teacher leadership. A Teacher Leadership Advisory Committee is also being formed to provide direction in the state of Georgia for teachers who desire to be leaders in their schools. This work continues with Georgia becoming a partner with the Center for Teacher Quality to provide research and take advantage of resources for teacher leadership.
- HB 790 Update Paul Shaw and Rebecca Mick met with Judge Malahi on June 13, 2018. It was
 determined that the law was not meant to force the Agency to send any case to OSAH within 30 days (it
 is not trying to change how PSC and State attorney General's Office handles cases). The law is meant to
 give the petitioner the opportunity to go to OSAH directly to request a hearing after 30 days.

- a) When hearing is requested, must be submitted to OSAH and AG offices within 30 days.
- b) Penalty up to \$1000 can be issued for each violation. Not meant for Agency, but a tool for judges in contempt of court scenarios.
- c) Impact on GaPSC-increases our work load since there are other matters every month that have legally mandated time line requirements that do not go away despite this law's mandated 30 day deadline being added to list.
- d) Impact-May want to utilize our resources more judiciously by not sanctioning minor infractions such as grabbing a student, misuse of sick leave, and use of profanity.
- e) Impact- AG's office will have less time to negotiate a reduced sanction. Sometimes educators request a hearing simply to negotiate and have no intention of participating in a hearing. Will probably create a larger backlog of cases going to ALJ hearing
- f) Impact-May want to change slight wording and request rule change by asking educator if they want to accept or reject sanction recommended rather than requesting hearing. This won't need to be done unless the interpretation of the law becomes stricter.
- g) In 2017, approximately 51% of the cases, where you all recommended a sanction against an applicant or certificate holder, ended up asking for a hearing.
- Chair Report Chair Luigs called upon Enjolia Farrington to discuss the Future Educator Signing Day event that held in Henry County. Approximately 45 students committed to begin their journeys to become educators. Last year they had approximately 18 students pledge so there was a significant increase. Their families attended the event and the media was there as well.

- the Induction passing score (220 GACE scale), which equals the RSV minus 2 CSEM (39 raw score points), until score reports are issued dated on or after September 1, 2019, when the induction passing scores for all teaching field content assessments are raised.
- Beginning with score reports dated on or after September 1, 2019, the Induction passing score (235 GACE scale) will equal the RSV minus 1 CSEM (43 raw score points).
