12. <u>STUDENT LOAN SUSPENSION / REINSTATEMENTS</u>

The Commission reviewed the report, which indicated that there were 46 certificates suspended from February 10, 2005 through March 10, 2005. There were 6 certificates that had been *reinstated* because restitution is now being made on those student loans.

13. FINAL DECISIONS BY OPERATION OF LAW

The Commission reviewed the report, which advised of 15 cases now closed without an appeal for a hearing before an Administrative Law Judge. The report also advised that there were 4 cases closed without an appeal for a review hearing before the Commission.

B. Educator Preparation Standing Committee Report

Dr. Craig Smith, presented the Educator Preparation report.

- 1. Recommendation to the Commission for Appalachian Technical College The Standing Committee for Educator Preparation recommends that the Appalachian Technical College Paraprofessional Program Progress Report submitted January 15, 2005 demonstrates satisfactory progress. Areas for improvement may be removed.
- 2. Recommendation to the Commission for Coastal Plains RESA The Standing Committee for Educator Preparation recommends that the Coastal Plains RESA One-Year Supervised Practicum Progress Report submitted October 1, 2004 demonstrates satisfactory progress. Areas for improvement may be removed and approval status may be changed to Developmental Approval.
- 3. Recommendation to the Commission for Coweta County Schools The Standing Committee for Educator Preparation recommends that the Coweta County Schools One-Year Supervised Practicum Program be granted Developmental Approval.
- 4. Recommendation to the Commission for Georgia Southwestern State University The Standing Committee for Educator Preparation recommends that the Georgia Southwestern State University Progress Report submitted February 15, 2005 demonstrates that progress is being made in preparation for the PSC/NCATE Spring 2005 on-site approval review.
- 5. Recommendation to the Commission for Griffin RESA The Standing Committee for Educator Preparation recommends that Griffin RESA be granted Approval to offer online delivery of the Special Georgia Technology Certification Course in partnership with Flint River Technical College.

- 1. - Fort Valley State University shall accept no new candidates into either undergraduate or graduate programs leading to state educator certification beginning with the summer semester 2005.
- Candidates currently accepted in the undergraduate and/or graduate programs may be granted state certification by May 31, 2006. No certifications will be issued after May 31, 2006.
- Fort Valley State University shall undergo an initial onsite review when the Commission determines they are prepared to do so.
