### 12. OTHER BUSINESS

The Educator Ethics Review Committee reviewed Probable Cause Determination case # 07-8-104. Due to an administrative/clerical error, the Commission failed to articulate at their February 14<sup>th</sup>, 2008 meeting which standards of the Code of Ethics had allegedly been violated. Due to this oversight, the same materials were resubmitted at the March 13, 2008 meeting so that a decision could be made regarding which standards are alleged to have been violated and to also affirm the sanction. Although, due process might not require that the educator be informed of the standards allegedly violated at the time a finding of probable cause is made, it has been the Commission's practice to do so. Therefore, the matter was resubmitted for review and it was determined that the violated standards include Criminal Acts, Failure to Make a Required Report and Professional Conduct. They also affirmed that a Suspension for a period of one year as recommended at the February 14, 2008 meeting is the appropriate sanction.

## 13. STUDENT LOAN SUSPENSION / REINSTATEMENTS

The Commission reviewed the report, which indicated that there were 2 certificates suspended from February 14, 2008 through March 13, 2008. There were 8 certificates that had been *reinstated* because restitution is now being made on those student loans. There were 2 issues where notification had been received to suspend but releases were received prior to the actual suspension being implemented. Restitution is now being made on those student loans.

## 14. FINAL DECISIONS BY OPERATION OF LAW

The Commission reviewed the report, which advised of 3 cases now closed without an appeal for a hearing before an Administrative Law Judge. The report also advised that there were 5 cases closed without an appeal for a review hearing before the Commission.

**B.** Dr. Gary Walker introduced Harold Chambers, Director of Coastal Plains RESA, who explained the PSC project on Alternative Preparation leading to Alternative Certification sponsored by his RESA. Scott Chestnutwood, Coastal Plains RESA provided additional details on the project. Kelly Henson elaborated on the Alternative Preparation/Certification plans.

**C.** Kelly Henson spoke briefly about the PSC Recruiting program. We have three recruiters, but two of the positions are currently vacant. We are currently conducting interviews. He stressed the need for PSC to have a closer working relationship with all statewide recruiting efforts.

**D.** Kelly Henson thanked the commission and others for the making the retreat so successful.

**E.** Kelly Henson spoke briefly about House Bill 1321, which has passed the House and that the PSC would like to propose an amendment to the Senate.

**MOTION:** (Muns / Vasconcelos) To request that our Executive Secretary, Kelly Henson address the Senate Education Committee regarding the PSC's objection to House Bill 1321 as passed by the House. **PSC ACTION:** Approved
