I. WORK SESSION

- Executive Secretary Report Matt Arthur spoke briefly crossover day and the legislative session. He announced that we were in the midst of reviewing the tests that we require teachers to take for certification. He thanked Governor Kemp for the outstanding job that he has done in handling the Coronavirus.
- Rules Initiation and Adoption Anne Marie Fenton presented the rules for adoption and initiation. On January 9, 2020, the Commission initiated certification rules and educator preparation rules, which were brought to them today for their consideration to adopt. If adopted, the Educator Preparation rules will become effective April 15, 2019; the Certification Rules will become effective July 1, 2020. Four public comments were received on the Educator Preparation rules, which were given to Commissioners. Penney McRoy discussed the public comment for the Educator Preparation Rules. 19 certification rules and 6 educator preparation rules were presented for consideration in initiating, which were each previewed in February, except for those rules that reflected the recent change to the ethics assessment requirement, which state that test takers will only need to take the assessment once, at program entry. Permanent Revocations – Tanis Miller, Legal Counsel, gave a PowerPoint presentation titled Disciplinary Actions. This presentation addressed Permanent Revocations, Automatic Revocations, and Ineligibility.
- Disciplinary Actions Tanis Miller, GaPSC Legal Counsel, gave a PowerPoint presentation on Disciplinary Actions that included Permanent Sanctions, Automatic

Revocation and Ineligibility.

• Commission Chair Report – Chair Sirmans spoke briefly about the Executive Secretary Evaluation and gave the timeline for the tasks that will be needed to finalize the review process. He also gave all Commissioners a copy of the finalized evaluation document. He also mentioned how excited everyone was for the retreat and Governor Kemp and State Superintendent Richard Woods visit.

Neil Gerstenberger, the Chief of Staff for the Georgia Crime Information Center (GCIC) at the Georgia Bureau of Investigation provided a presentation about the Rap Back Service. Rap Back is a program initiated by the FBI to provide non-criminal justice agencies with notifications

when employees (educators) are arrested or have significant judicial events, such as a conviction in a criminal case. The service is provided at no cost to the agency. To be eligible for the service, the PSC would need statutory authority to retain the fingerprints of those they wish to enroll in the service. The Rap Back service is expected to commence during the summer of 2020.
