#### **EXECUTIVE SECRETARY REPORT**

- 1. Dr. Toth expressed his appreciation to Paine College for their wonderful hospitality to the Commission and for the splendid dinner and entertainment offered to the commissioners and staff last evening.
- 2. Dr. Toth gave an update on the search for new office space for the PSC as well as the strategic planning effort. The strategic planning consultants will be meeting with individual members of the Commission some time during the end of May or the first of June. The process will be completed by June 30, 2001.
- 3. Dr. Toth reported that in January of 2001, the PSC convened four panels of practicing Georgia Middle School teachers and teacher-educators for the purpose of reviewing and setting scores for the new Middle School Praxis II certification tests in the four primary concentration areas. The Middle School panels made the following recommendations for testing requirements.

0049 Middle School English Language Arts

0069 Middle School Mathematics

0439 Middle School Science

0089 Middle School Social Studies

Passing scores should be "phased in" over a five-year period. Scores would be raised from the lowest panel-recommended scores to the highest panel-recommended scores over a five-year period for each of the four tests.

Dr. Toth discussed the present Praxis II testing requirement for Middle Grades, (0146 Middle School: Content Knowledge and 0523 Principles of Learning and Teaching 5-9), and stated that, if the recommendation is approved by the Commission, there would be a one-year transition period needed due to the distribution of published materials containing information on both sets of tests.

<u>MOTION:</u> (Harrison/Cribbs) To approve the new Middle School Prixis II certification tests, passing scores, and phase-in schedule recommended by the Middle School Panel, effective July 1, 2001; and to rescind the current Middle School Praxis II certification test, effective July 1, 2002.

**ACTION:** Unanimously approved.

**4.** Dr. Toth mentioned that there are plans to discuss the technology requirement for renewal at the *Governor's Implementation Task Force* meeting in May, and that he will give an update to the Commission at our next meeting to be held at the Southern Center for International Studies in Atlanta in June.

**5.** Dr. Toth gave an update on the new *Teach for Georgia* program. This program will be discussed further at the June meeting.

#### IX. CHAIRMAN'S REPORT

Chairman Culbreath also expressed his appreciation to Dr. Lewis and all the other fine members of Paine College's Education Department for affording our Commission the privilege of holding its May meeting on their campus.

#### X. OTHER BUSINESS

#### A. Rulemaking

Dr. Toth asked Phil Blackwell to review the rules which the Commission has filed their intention to adopt at this meeting. These proposed rules deal with the International Exchange Certificate, PSC Accepted Accreditation rather than Regional Accreditation, and Student Loan Suspensions. The new proposed rules were distributed, and the following motion was made.

**MOTION:** (Wallace/Bailey) To officially adopt proposed amendments to Rule Nos. 505-2-.24 and 505-2-.35, and to adopt a new Rule 505-6-.08. (These rules will become effective on June 1, 2001.) **ACTION:** Approved.

## XI. ADJOURNMENT
