# V. RULE MAKING

Phil Blackwell presented the following rulemaking item for approval of the Commission:

#### Recommendation

It is recommended that the Professional Standards Commission, in accordance with the Georgia Administrative Procedure Act, (1) rescind Rules in Chapter 505-3 Teacher Education, effective December 1, 2001, as per attached index; and (2) adopt new Rules in Chapter 505-3 Teacher Education, effective December 1, 2001, as per attached index.

#### **Discussion**

The purpose of the proposed changes to Chapter 505-3 is to bring the standards for approval of educator preparation programs in line with recent changes in Georgia (new technology requirement; Georgia Teacher Alternative Preparation Program) as well as with new standards for Unit and Program Approval adopted by the National Council for the Preparation of Teacher Education (NCATE).

Two categories of changes being proposed in the recommended new rule:

1. Revision of 505-3-.0l, Requirements and Standards for Approving Professional Education Units and Programs Preparing Education Personnel.

The effect of the proposed changes would be to:

- a. Expand the definition of Professional Education Unit to include Local Education Agencies, Regional Educational Service Agencies, and other agencies who might propose alternative initial preparation programs or endorsement programs for approval by the Professional Standards Commission.
- b. Clarify the relationship between the Professional Standards Commission and the National Council for Accreditation of Teacher Education (NCATE) with respect to unit approval (provide for joint rather than concurrent NCATE/PSC reviews).
- c. Align state program approval standards with standards published by national specialty organizations.
- d. Update the Georgia Specific Requirements to include new legislative requirements.
- 2. Revision of field-specific program approval rules to incorporate standards published by the national specialty organizations, when these are available.

For program fields for which national specialty organization standards are not available, no new standards are proposed at this time.

#### VII. EXECUTIVE SECRETARY REPORT

Dr. Toth gave the following Executive Secretary's report:

- **A.** Gary Walker was welcomed as a new commission member. Mr. Walker replaced Debbie Lane as one of the commission representatives of the private sector. He is currently a financial consultant and previously served as an assistant superintendent in the Cartersville City School System, Superintendent of the Valdosta City School System, and he has served the state Close The Gap committee.
- **B.** A recommendation has been made to the governor to fill Thomas Harrision's Commission vacancy, which is expected to be acted on by the January meeting of the Commission.
- **C.** Commissioner, Janet Scott, and Chief Investigator, John Grant, are currently attending a code of ethics meeting in San Diego.
- **D.** The PSC has been asked to sponsor a Closing the Gap conference in conjunction with the Closing The Gap Commission and the Georgia Partnership of Education. The Education Commission of the States has agreed to provide funds for conference speakers who have had success with Closing The Gap.
- **E.** A group of consultants is currently completing an organizational study of the PSC. A preliminary report has been reviewed and the final report should be ready for presentation to the commission at the December meeting.
- **F.** Another group of consultants is currently studying the agency and will be developing a communications plan to guide the agency in recruiting and retaining teachers and making the teaching field more attractive. When this report is ready it will also be presented to the Commission.
- **G.** A meeting was recently held with Ron Newcomb, the Governor's Policy Advisor on Education, Tom

Upchurch with the Georgia Partnership on Education, and the Presidents of the Professional Association of George Educators, Georgia Association of Educators, Georgia School Boards Association, and Georgia School Superintendents Association, to talk about the work that Fran Watkins and the Educator Preparation staff have been doing with a committee on teacher induction, mentoring and Teacher Support Specialists. A report is expected to be given at the November 15th Education Coordinating Council Meeting. Dr. Toth provided an overview of some of the statistics in the report.
