#### V. EXECUTIVE SECRETARY'S REPORT

Matt Arthur spoke briefly about the following topics:

a) The Preparation Program Effectiveness Measures (PPEM) indicate how well state approved programs are preparing their candidates for a career as a classroom teacher. This tool also provides contextual data for each program provider which includes program enrollment and employment needs. This information will be released on November 20<sup>th</sup>. The PPEM is becoming more popular across the state as it houses lots of good information and I am very proud of the work that the Educator Preparation division has done in overseeing

the PPEM.

- b) I would also like to mention the collaborative work that the Certification and Educator Preparation division have done in working to increase the of Computer Science teachers in Georgia and getting the word out about this important field.
- c) Julie Beck hosted a webinar on October 28<sup>th</sup> for faculty and staff from endorsement program providers. The webinar focused on the evidence and practices they can utilize to demonstrate continuous improvement and to meet approval standards. Our staff continues to try to collaboratively with program providers across the state.
