III. Conclusions of Law

The language in paragraphs 1, 2 and 3 of the Conclusions of Law are adopted in their entirety.

The language in paragraphs 4, 5 and 7 of the Conclusions of Law are deleted in their entirety.

The Commission adds a new paragraph 4 which reads as follows:

4.

Based on paragraph 10 of the Findings of Fact which states:

On May 8, 2001, the Respondent called Ms. Campbell into his office and indicated to her that he had decided that it was time for her to transfer to another school. He informed her of vacancies which existed. He warned her that, if she did not transfer, he would put the two December, 2000 letters back in her file and 'micromanage' her.

the Commission finds a violation of Standard 10 of the Code of Ethics (Professional Conduct).

The Commission adds a new paragraph 5 which reads as follows:

5.

Based on paragraph 11 of the Findings of Fact, which states:

Under normal procedures in the evaluation process, Ms. Campbell should have been given a formative conference with the Respondent during the middle of the year to discuss any deficiencies in her performance. During her four years at the school, Ms. Campbell was only given one formative conference, which occurred in January of 1998.

the Commission finds a violation of Standard 10 of the Code of Ethics (Professional Conduct).

The following language in paragraph 6 of the Conclusions of Law is deleted:

As mentioned before, the evidence in the record before the undersigned did establish (sic) that the Respondent displayed very poor skills as a supervisor in his dealings with Ms. Campbell, but the evidence does not establish that the Respondent was dishonest or lacked integrity. Being vague or evasive is not the same thing as being dishonest. Certainly at times the respondent displayed questionable judgment in his interaction with Ms. Campbell especially in the tactics he used to try to convince her to seek a transfer, but none of his actions is of such an egregious nature as to rise to the level of a violation of this standard.

IV. Decision

1.

The Commission rejects the decision as written in the Initial Decision of the Administrative Law Judge. The Commission concludes that, based on a review of the record, the recommendation of the Administrative Law Judge in Part IV. Decision that no sanctions be applied against the Respondent does not adequately reflect that there was a violation of Standard 10 of the Code of Ethics (Professional Conduct). The Commission Hereby **ORDERS** that the Respondent's Georgia Educator Certificate be issued a reprimand and the reprimand shall be effective immediately.
