The Educator Ethics Review Committee recommended to approve a no probable cause determination on 40 cases reflected on the *Applications for Certification Report*.

#### 10. REVIEW HEARING EXTENSIONS

The Commission reviewed the *Review Hearing Extensions Report* concerning 5 hearing cases. An Administrative Law Judge rendered Initial Decisions on each case referenced in the report. The report indicates Orders were issued to extend time by 30 additional days to preserve the Commission's time to conduct review hearings.

#### **PSC ACTION:** Approved

#### 11. STUDENT LOAN SUSPENSION / REINSTATEMENTS

The Commission reviewed the report, which indicated that there were 15 certificates suspended from July 27, 2006 through September 14, 2006. There were 22 certificates that had been reinstated because restitution is now being made on those student loans. There were 6 issues where notification had been received to suspend but releases were received prior to the actual suspension being implemented. Restitution is now being made on those student loans.

#### 12. FINAL DECISIONS BY OPERATION OF LAW

The Commission reviewed the report, which advised of 12 cases now closed without an appeal for a hearing before an Administrative Law Judge. The report also advised that there were 8 cases closed without an appeal for a review hearing before the Commission.

#### **B.** Educator Preparation Standing Committee

Dr. Mary Outlaw presented the report of the Educator Preparation Standing Committee.

#### Fort Valley State University

Fort Valley State University requests Developmental Approval of its professional education unit and the following educator preparation programs:

- Agriculture Education (6-12; Initial)
- Middle Grades Education (4-8; Initial and Advanced)

A Georgia Professional Standards Commission Board of Examiners (BOE) team, including one NCATE representative who focused solely on Standard 2, conducted an on-site Developmental Review June 24 – 28, 2006.

The University agreed with the BOE findings and submitted a detailed rejoinder addressing each of the areas for improvement and the unmet standard (Standard 6 was not met for the advanced middle grades program).

#### STANDING COMMITTEE RECOMMENDATION:

- 1. Developmental Approval for the professional education unit.
- 2. Developmental Approval for the initial educator preparation programs in Agriculture Education and Middle Grades Education.
- 3. A Progress Report is due October 23, 2006 addressing the following:
  - a. Describe the level of involvement/collaboration of Arts & Sciences faculty with the College of Education as it relates to governance and planning.
  - b. Provide the qualifications (first page of vitae) of all faculty who teach education candidates (including part-time, adjuncts and faculty employed outside the professional education unit).
  - c. Provide confirmation that plans described in the Rejoinder to the BOE Report are completed; provide a timeline for completion for those that are not completed by the submission of the Progress Report.
  - d. Provide the name and qualifications of the new Field Placement Coordinator.
  - e. Describe the structure in place to ensure that field placement requirements are documented and met.

MOTION: (Greenway / West) The findings of fact found by the Administrative Law Judge as indicated in the Initial Decision were hereby rejected. Based on a review of the record the following facts were hereby adopted and incorporated herein: In 1976, while living with his then girlfriend in Riverside, California, Petitioner shot his roommate and her boyfriend during a psychotic episode. The Educator admitted to killing these two people in sworn testimony. He was found not guilty by reason of insanity and sentenced to treatment at the Patton State Mental Hospital where he spent 10 years. In 1979, while still confined to Patton State Hospital, Petitioner "slugged a psychiatric technician and broke his jaw." The Educator has admitted in sworn testimony that he assaulted the technician. The State of California filed criminal charges against him and he entered a plea of nolo contendere. The appellate court reversed his plea, holding that he was still an inmate at the State Hospital and had not been through the proper procedures to determine if sanity had been restored. A jury ultimately found Petitioner not guilty of these charges. In 1980, while still confined at Patton State Hospital, Petitioner choked another patient. The Educator admitted to this in sworn testimony. In 1985, Petitioner petitioned the State of California to declare that his sanity was restored. At the 1985 restoration of sanity trial, one of the psychiatrists testifying on behalf of Petitioner, Dr. Oliver, opined that Petitioner had had a severe paranoid psychosis, possibly caused by a manic depressive illness. In contrast, Dr. Harvey Oshrin and Dr. Robert L. Flannagan, both psychiatrists, and Dr. Levy, a psychologist, diagnosed Petitioner as having non-curable paranoid schizophrenia. During the jury trial Petitioner testified that he broke the psychiatric technician's jaw in 1979. He claimed he struck the technician in self-defense. Regarding the choking incident, the hospital notes read into the record stated:

[Petitioner] was observed choking another patient. Approached suspect, tried to break the choking apart. [Petitioner] had to be physically separated from choking the other patient. He continued to be uncontrollable and aggitated [sic] talking, very bizarre and had to be escorted by five male staff members to his room.

After hearing all the evidence including that of several psychiatrists who gave differing opinions as to Petitioner's mental health, the jury determined that Petitioner's sanity was not restored. Petitioner appealed the jury's verdict to the Court of Appeals. In 1987, a judge ordered that Petitioner's sanity was restored and he was released. Petitioner has not been arrested for a crime since his release from Patton State Mental Hospital in 1987. It is unknown whether Petitioner currently receives treatment for the psychiatric disorders that caused him to kill people and injure two others in the 1970s and the early 1980s. An affidavit from Dr. Saundra Maass-Robinson, a psychiatrist and expert witness, opined that because Petitioner's present treatment was unknown, she could not say that Petitioner was not at risk for relapsing and committing further violent crimes. Petitioner obtained a teaching certificate in Georgia in 2004 and has held it since then.

The Conclusions of Law reached by the Administrative Law Judge as indicated in the Initial Decision were hereby rejected. Based on a review of the record the following conclusions were hereby adopted and incorporated herein: The Commission hereby concludes that the Petitioner's conduct violated Rule 505-6-.01(3)(a), Standard 1, Criminal Acts. The Commission prohibits its educators from committing or having committed *at any time* a felony or a crime involving moral turpitude. There is no statute of limitations excusing an educator's past commission of felonies. The Commission concludes that the Petitioner did commit a criminal act when he committed a double murder in 1976 and when he subsequently injured the psychiatric technician in 1979. The Commission hereby concludes that the Petitioner's conduct "that impairs the certificate holder's ability to function professionally in his or her employment position. It does not require that the conduct occur during the time in which Petitioner holds a certificate to teach. The Court of Appeals has held that "it is sufficient for an administrative record to contain evidence of conduct by a school official from which an adverse consequence on the student body

can be inferred by the PSC, given the grave nature of the conduct itself." *PSC v. Alberson*, 273 Ga. App. 1, 14 (2005). The PSC is afforded "broad discretion" in applying its rules and standards in order to ensure that only those "fit to serve the public interest" as teachers are certified. *PSC v. Alberson*, 273 Ga. App. 1 (2005). The Commission concludes that it would place an adverse consequence on students to receive instruction and supervision from a man who killed two people, suffered from severe mental health conditions which could lead to violence and whose possible relapse cannot be predicted. The obvious adverse consequences include students' fear and distrust of Petitioner, which would compromise their learning and possibly their safety.

The Commission hereby concludes that the Petitioner's conduct violated Rule 505-6-.0(5)(a) 7., (Other Good and Sufficient Cause) and as such he is unfit for employment as an educator. The Court of Appeals discussed this ground for sanction by quoting a United States Supreme Court opinion stating that a school needs to "impose disciplinary sanctions for a wide range of unanticipated conduct disruptive of the educational process." PSC v. Alberson, 273 Ga. App. 1, 23 (2005) (internal citations omitted). The Court found that "other good and sufficient cause" was not unconstitutionally vague. PSC v. Alberson, 273 Ga. App. 1 (2005). It exists to capture situations not specifically covered by the other standards in the Code of Ethics but that are nevertheless harmful or disruptive of the educational process. PSC v. Alberson, 273 Ga. App. 1 (2005). The PSC is afforded "broad discretion" in applying its rules and standards in order to ensure that only those "fit to serve the public interest" as teachers are certified. PSC v. Alberson, 273 Ga. App. 1 (2005). The Commission concluded that a criminal background involving murder and assault as well as serious mental illness that an expert has opined could reoccur if untreated or ignored constitutes "other good and sufficient cause." Additionally, Petitioner has not presented any evidence as to present treatment. The expert in this matter, Dr. Saundra Maass-Robinson, a respected psychiatrist, opined that without knowledge of Petitioner's current treatment plan, she could not say that he would not again become violent. Petitioner did not rebut, or even reply, to her opinion.

The Decision of the Administrative Law Judge to REVERSE the Professional Standards Commission's proposed sanction to revoke the educator's certificate and that no action be taken was hereby rejected. The Commission concluded that a sanction was appropriate in this particular case because the actual record in the case does not support a No Probable Cause determination. Because the essential facts of this case are undisputed, the Commission finds that the Petitioner violated the Code of Ethics for Criminal Acts, Professional Conduct and Other Good and Sufficient Cause. This finding is based on his criminal conduct of murdering two people and subsequently injuring a psychiatric technician and is also based on the expert opinion of Dr. Maass-Robinson. The Commission hereby ordered that the Georgia educator certificate held by Larry Johnson be Revoked effective September 14, 2006.

**F**. A report titled "Educating School Teachers" written by Dr. Arthur Levine, Professor at Columbia University, will be relased to the media at the national Press Club in Washington, D.C. An email received from NCATE regarding this report was given to the commissioners requesting that they visit the web-site of NCATE to learn more about this issue.

**G.** The Georgia Alliance of Education Heads met on August 30<sup>th</sup>, 2006, at the Evergreen Conference Resort at Stone Mountain. They have identified five strategic goals. Each goal will have a lead agency and all agencies will have input.
