IX. GACE PRESENTAION

Anne Marie thanked the employees from PSC and ETS for collaborating together to make the transition to ETS. She introduced Clyde Reese, ETS who gave the presentation on GACE Standard Setting. He also addressed questions/concerns that Commissioners had.

X. GACE STANDARD SETTING

The next order of business is the GACE Standard Setting. Kelly Henson will present each GACE Standard Setting recommendation.

- 1. We wish to initiate the standard setting process for the 43 GACE content assessments. We propose that for all tests composing these assessments EXCEPT GACE American Sign Language Test II two passing scores be set:
 - Professional: at a value equal to the passing score recommended by the GACE Standard Setting Panel
 - Induction: at a value equal to two conditional standard errors of measurement lower than the passing score recommended by the GACE Standard Setting Committee.

MOTION: (Pam Walker / Bettina Tate) To set the Professional and Induction passing scores on the GACE content and support services assessments as described.

3. We wish to initiate the standard setting process for the GACE Program Admission assessment (formerly Basic Skills Assessment). We propose that for each of the three tests composing this assessment, the passing score be set at a value equal to two conditional standard errors of measurement lower than the passing score recommended by the GACE Standard Setting Committee.

<u>MOTION</u>: (Julia Bernath / Kami Luigs) To set the passing scores on each test comprising the GACE Program Admission Assessment at a value that is equal to two conditional standard errors of measurement lower than the passing score recommended by the GACE Standard Setting Committee?

4. We propose that beginning with the October 2013 GACE administration and up until the GaDOE-adopted statewide teacher evaluation is consistently in place, but no earlier than 2014, all examinees who pass the GACE assessment at either the Induction level or Professional level have met the Georgia Special Requirement in Rule 505-2-.20 to pass the content knowledge assessment(s) appropriate to the field of certification.

MOTION: (Valerie Mateen /Dr. Adrian Epps) Until the GaDOE-adopted statewide teacher evaluation is in place, but no earlier than 2014, examinees who pass the GACE assessment at the Induction level have met the content assessment requirement outlined in Rule 505-2-.20 Special Georgia Requirements.

ACTION: Approved Abstention: Pam Williams

5. We propose that after the GaDOE-adopted statewide teacher evaluation measure is consistently in place, but no earlier than 2014, examinees who pass the GACE assessment at the Induction level must meet the content knowledge assessment requirement outlined in Special Georgia Requirements by either 1) passing the GACE assessment at the Professional level within three (3) years of employment in a public school in Georgia, or 2) achieving no fewer than two (2) proficient ratings and one exemplary rating on GaDOE-adopted statewide teacher evaluation measure within three (3) years of employment in a public school in Georgia.

<u>MOTION</u>: (Scott Justus / Dr. Adrian Epps) After the GaDOE-adopted statewide teacher evaluation measure is in place, but no earlier than 2014, examinees who pass the GACE assessment at the Induction level must meet the content knowledge assessment requirement outlined in Special Georgia Requirements by either 1) passing the GACE assessment at the Professional level within three (3) years of employment in a public school in Georgia, or 2) achieving no fewer than two (2) proficient ratings and one exemplary rating on GaDOE-adopted statewide teacher evaluation measure within three (3) years of employment in a public school in Georgia.
