#### I. WORK SESSION

A. Dr. David Hill presented/spoke about the Tiered Certification Task Force.

**B.** Penney McRoy presented rules. In September, the Commission was introduced to rules that they initiated at the October 11, 2012, Commission meeting. At today's Commission meeting, they were asked to rescind/amend/adopt the following rules: *Certification, Amend Rule 505-2-.32 APPEALS*.

#### Educator Preparation -

Rescind the current Rule 505.3-.01 REQUIREMENTS AND STANDARDS FOR APPROVING PROFESSIONAL <u>EDUCATION</u> UNITS AND EDUCATOR PREPARATION PROGRAMS and adopt a new rule with the same number and name.

These rules, if adopted, will have an effective date of January 15, 2013.

Sent to them last Thursday and also on their your desktops are:

- 1) The Adopt Rules Packet;
- 2) The one comment received during the public comment period (October 26, 2012 November 24, 2012), along with a brief staff analysis of each point covered in that comment; and
- 3) Follow-up communication received from the person submitting the public comment, which indicates she is satisfied with the staff response to her feedback.

We will be bringing two rules (both revisions) to you for your consideration to initiate at the January meeting. It is important to us to provide a preview to you today, which will be delivered by Bobbi Ford, Program Approval Education Specialist. These rules include:

In May of 2011 Hilda earned a promotion to the role of Program Approval Director, the role in which she continues to serve today with great success. #### Phyllis Payne - 5 years
