### I. WORK SESSION

- A. EXECUTIVE SECRETARY REPORT Kelly Henson spoke briefly about the upcoming work session agenda items and gave the Commissioners a hand-out. He also wished everyone a happy holiday.
- B. STANDARD SETTING Jan Ruthven and Wanda Swiggett joined us remotely from ETS. As a reminder, the Georgia Ethics for Educational Leadership Assessment—Program Entry (Test 370) is currently available for EPP optional use. We encourage EPPs to strongly encourage their educational leadership candidates to take it for their benefit. The following is a recap of the policy for this assessment:
- July 1, 2016: All candidates admitted to any GaPSC-approved Educational Leadership program (current program or the new tiered model) on or after July 1, 2016, must have completed (do not have to pass) the Georgia Ethics for Educational Leadership Assessment Program Entry (Test 370) prior to becoming enrolled. A candidate who completes this program entry requirement (Test 370) for Tier I, does not have to complete Test 370 for Tier II.

All candidates completing any GaPSC-approved Educational Leadership program (current program or the new tiered model) on or after July 1, 2016, must attempt the Georgia Ethics for Educational Leadership – Program Exit (Test 380) prior to completion and must pass the assessment to earn certification in the field of Educational Leadership. A candidate who passes the Program Exit (Test 380) for Tier I certification, does not have to pass Test 380 for Tier II certification.

Therefore, we are asking you today during the Commission meeting to set the passing standard for the Program Exit Test 380.
