I. WORK SESSION

- Kelly proposed that the Commissioners have a passing induction score and a passing professional cut score. His rationale was that in October we would have new tests that would be more rigorous and aligned to tiered certification. He asked the Commission to informally agree that ETS move forward with their work preparing for our September meeting the the knowledge that we are favorably disposed to establish a passing induction and a passing professional cut score. He also proposed that the Commission informally agree on the following:
 - Those passing at the induction level would be required to pass the test at the professional level during the three years of their induction certification. Additionally, we will develop an opportunity for educators to satisfy this requirement by demonstration of performance.
 - Passing induction will likely be a score of 220 (2 standard errors of measurement below committee recommendation and passing professional will be at 250 (committee recommendation).
 - When our preparpation program providers have had the opportunity to align programs to the new tests we will very strongly consider a recommendation to the Commission to move the "passing induction to 1 standard error of measurement below committee recommendation.
 - Our position on GACE scores and how they are utilitzed in TPPEM will likely be that institutions will be given credit for a passing score for either passing induction or passing professional. However, another measure in TPPEM is the percentage of teachers that move from induction to professional.
 - School districts will receive more information from us in the near future.
- 2) Kelly thanked Rebecca for her work on unsats. We take action when we receive unsats and not at the ned of the certification renewal period.
- 3) Kelly thanked Mike Bochenko and Dr. Winifred Nweke for their work at the PSC. Mike has accepted a position at Valdosta State University and Dr. Nweke has accepted a position at Clayton State University.

- 4) Kelly Henson and Chair Elkins thanked Commissioner Bill Haskin and Stephanie Leggett for their work on the Commission. Both Commissioners brought a teachers perspective to the Commission. We will miss them both.
- 5) Kelly announced that we will not have a meeting in August. Our September meeting will be a little longer than normal. Please plan to adjourn at approximately 2:00 p.m. or 2:30 p.m.
- 6) Anne Marie Fenton gave the Commissioners "A Quick Glance at Important GACE Information" handout. She briefly explained that this contained ETS contact information, the transition from ES to ETS and remaining testing opportunities with ES. _____ gave a powerpoint presentation on setting passing scores for the GACE Paraprofessional Assessment.

She compiled them and highlighted some of the narrative responses from the staff and then sent them to the executive committee. The executive committee met last week with Kelly. IX. PARAPROFESSIONAL STANDARD SETTING

The Executive Secretary presented the following:

We wish to initiate the standard setting process for the GACE Paraprofessional Assessment. We propose that the passing score be set at a value that is equal to two conditional standard errors of measurement lower than the passing score recommended by the GACE Standard Setting Committee. For the form of the GACE Paraprofessional Assessment that was evaluated by the GACE Standard Setting Committee, this represents a passing score of 48 items correct out of 75 total.
