The Georgia Professional Standards Commission (PSC) met on Thursday, July 10, 2014, at 12:30 p.m.

I. WORK SESSION

A. Kelly announced that PSC will not use student performance data from the TKES/LKES systems for certification renewal in academic year 2014-15. We will, however, use observation data (TAPS) and superintendents must report ratings of Ineffective, Needs Development, and Unsatisfactory. A detailed email to all school superintednents regarding the use of TAPS and LAPS for reporting unsatisfactory performance to PSC in 2014/2015 will be sent out tomorrow.

B. GACE Standard Setting - At the May Commission meeting, Educational Testing Service (ETS) joined us and previewed the GACE standard setting process they planned to use for the new Service fields of Curriculum and Instruction, Instructional Technology, and Teacher Leadership, as well as Educational Leadership. At today's Commission meeting, the Commission was asked to set the passing standard for these assessments.

As a reminder, ETS conducted separate test development and bias review committees in Atlanta, and have most recently conducted standard setting studies via committees of Georgia P-12 educators and Educator Preparation Providers (EPPs).

Joining us from ETS today is George Powell, Vice President, Teacher Licensure & Certification; Janet Cook, Executive Director, Teacher Licensure & Certification; and Wanda Swiggett, Research Project Manager, Licensure and Credentialing Research. Wanda will provide you with the results of the standard setting work.

We propose that beginning with the August 2014 GACE administration, all examinees who pass one of these new GACE assessments at the Professional level have met the appropriate certification assessment requirements. Once sufficient test-taker data are available to make valid inferences, on or about July 2015, the Professional-level passing score for the Educational Leadership assessment will be reviewed by the GaPSC. Just as with all GACE assessments, the GaPSC will regularly review data from Curriculum and Instruction, Instructional Technology, and Teacher Leadership assessments, assuming sufficient test-taker data are available.

He addressed the rationale for change in program and certification rules. He spoke briefly about the two tier preparation system that the Ed Leadership Task Force is proposing and the approximate implementation timeline.
- **E**. Dr. David Hill gave a presentation on the Proposed Redesign of Professional Learning Requirements for Georgia Educators. The intent of the redesign is to link professional learning to educator performance and certificate renewal. Dr. Hill addressed the task force recommendations, remaining work and timeline.
- **F**. Chair Report Chair Elkins welcomed Kami Luigs, congratulated Christy on the newest member of her family, Miss Olivia Mary McGill and congratulated Terrie Ponder on her new position with Rome City Schools as Instructional Technology Specialist.

Chair Elkins announced that the executive committee will meet with Kelly next month regarding his evaluation. She invited the Commission to email her any suggestions/comments for Kelly and said that this could be confidential if they request it.

Chair Elkins also thanked the many of the PSC staff (Kelly Henson, Kelli Young, Penney McRoy, David Hill, Anne Marie Fenton) for serving on the Panel Discussion at Mercer University on July 10th.
