I. WORK SESSION

- Kelly Henson welcomed Dr. Sandy Leslie to the Commission.
- Anne Marie Fenton and Nathan Estell, ETS, gave a presentation and accepted questions on the EdTPA Standard Setting.
- Anne Marie Fenton presented the rules. The Commissioners will be asked to initiate the rule making process. These rules were previewed for you at the June work session.

RULES INITIATION

505-2-.05 PROFESSIONAL CERTIFICATE

It is proposed that GaPSC Rule 505-2-.05 PROFESSIONAL CERTIFICATE, dated April 15, 2015, be AMENDED to clarify experience requirements for renewal of the Performance-Based Professional certificate. Makes it so that Proficient/Exemplary TKES ratings used for renewal of a PRT may have been earned on any GA certificate.

505-2-.07 LEAD PROFESSIONAL CERTIFICATE

It is proposed that Rule 505-2-.07 LEAD PROFESSIONAL CERTIFICATE, dated July 1, 2015, be AMENDED to clarify that any pre-requisite certificates must be valid, renewable, and professional in order to qualify for the Lead Professional certificate and to update the name of the Teacher Support and Coaching endorsement.

505-2-.23 CERTIFICATE OF ELIGIBILITY

It is proposed that Rule 505-2-.23 CERTIFICATE OF ELIGIBILITY, dated July 1, 2015, be AMENDED to clarify the requirements for reissuance of a Certificate of Eligibility that is not converted to a full certificate prior to its expiration date.

505-2-.25 EXPERIENCE REQUIREMENTS

It is proposed that GaPSC Rule 505-2-.25 EXPERIENCE REQUIREMENTS, dated July 1, 2014, be AMENDED to further define acceptable P-12 settings for educator experience.

505-2-.26 CERTIFICATION AND LICENSURE ASSESSMENTS

It is proposed that Rule 505-2-.26 CERTIFICATION AND LICENSURE ASSESSMENTS, dated April 15, 2015, be AMENDED to clarify the assessment requirements for Permit holders converting to Induction or Professional certificates. Clarifies that foreign language Permit holders must pass GACE (if available) for conversion to Induction or Professional.

505-2-.31 GaPSC-ACCEPTED ACCREDITATION: VALIDATION OF NON-ACCREDITED DEGREES

It is proposed that GaPSC Rule 505-2-.31 EXPERIENCE REQUIREMENTS, dated July 1, 2014, be AMENDED with the new name of "GaPSC-ACCEPTED ACCREDITATION FOR CERTIFICATION PURPOSES" to define acceptable accreditation for P-12 educational settings.

505-2-.32 VALIDITY PERIODS AND DATING OF CERTIFICATES

It is proposed that GaPSC Rule 505-2-.32 VALIDITY PERIODS AND DATING OF CERTIFICATES, dated July 1, 2014, be AMENDED to clarify the effective dates of different types of certificates and licenses.

505-2-.34 ADD A FIELD

It is proposed that GaPSC Rule 505-2-.34 ADD A FIELD, dated January 15, 2015, be AMENDED to allow for issuance of a Supplemental Induction certificate in the fields of Early Childhood Education and Special Education General Curriculum/Early Childhood Education, in accordance with a change in Rule 505-2-.04 INDUCTION CERTIFICATE that has already been adopted.

505-2-.36 RENEWAL REQUIREMENTS

It is proposed that GaPSC Rule 505-2-.36 RENEWAL REQUIREMENTS, dated July 1, 2014, be AMENDED to establish that PLUs and CEUs awarded on or after 1/1/16 will not be acceptable for renewal credit, to clarify the requirements for acceptable PLUs, and to clarify the date after which educators must be employed or have Georgia experience in order to renew their certificates.

505-2-.44 RETIRED EDUCATOR CERTIFICATE

It is proposed that a new rule GaPSC Rule 505-2-.44 RETIRED EDUCATOR CERTIFICATE, with a new name and number, be INITIATED to create a new certificate type. This certificate will allow retired educators to quality as top priority substitute teachers without having to fulfill renewal requirements (such as college credit or retesting).

505-2-.91 COMPUTER SCIENCE

It is proposed that a new Rule 505-2-.01 COMPUTER SCIENCE, with a new name and number, be INITIATED to create a new certificate field.

505-2-.148 SPEECH AND LANGUAGE PATHOLOGY

It is proposed that GaPSC Rule 505-2-.148 SPEECH AND LANGUAGE PATHOLOGY, dated July 1, 2014, be AMENDED to adjust the numbering in section (5)(a)2.

505-2-.179 SPECIAL EDUCATION VISUAL IMPAIRMENT ENDORSEMENT

It is proposed that GaPSC Rule 505-2-.179 SPECIAL EDUCATION VISUAL IMPAIRMENT ENDORSEMENT, dated July 1, 2014, be AMENDED to change the base certificate requirements in accordance with a change in program admission requirements.

505-2-.182 TEACHER SUPPORT AND COACHING ENDORSEMENT

It is proposed that GaPSC Rule 505-2-.182 TEACHER SUPPORT AND COACHING ENDORSEMENT, dated July 3, 2015, be AMENDED to eliminate the option for a Supplemental Induction (SI) endorsement. The option for the SI is being removed because educators who hold Induction certificates may not be admitted to GaPSC-approved Teacher Support and Coaching Endorsement programs (See GaPSC Educator Preparation Rule 505-3-.105 TEACHER SUPPORT AND COACHING [TSC] ENDORSEMENT).

505-2-.184 DUAL IMMERSION EARLY CHILDHOOD EDUCATION ENDORSEMENT

It is proposed that GaPSC Rule 505-2-.184 DUAL IMMERSION EARLY CHILDHOOD EDUCATION ENDORSEMENT be INITIATED to create an endorsement that will allow qualified foreign language teachers to teach Early Childhood Education in dual immersion schools.

Educator Preparation:

505-3-.48 FOREIGN LANGUAGE EDUCATION PROGRAM

It is proposed that Rule 505-3-.48 FOREIGN LANGUAGE EDUCATION PROGRAM, dated May 15, 2014, be REPEALED and that a new rule with same number and the same title be INITIATED. The new rule is intended reflect changes in the standards published by the American Council on the Teacher of Foreign Languages.

505-3.56 SPECIAL EDUCATION GENERAL CURRICULUM EARLY CHILDHOOD EDUCATION PROGRAM (P-5)

It is proposed that Rule 505-3-.56 SPECIAL EDUCATION GENERAL CURRICULUM EARLY CHILDHOOD EDUCATION PROGRAM (P-5), dated May 15, 2014, be REPEALED and that a new rule with the same number and the same title be INITIATED. The new rule involves the adoption of the standards by the Council for Exceptional Children 2012.

505-3-.61 AUTISM EDUCATION ENDORSEMENT PROGRAM

It is proposed that a new rule with the name of AUTISM EDUCATION ENDORSEMENT PROGRAM, and a number of 505-3-.61, be INITIATED to prepare both general education and special educators to work with students with Autism. This endorsement does not qualify general education teachers to be the teacher of record for special education students.

505-3-.93 K-5 SCIENCE ENSORSEMENT PROGRAM

It is proposed GaPSC Rule 505-3-.93, K - 5 SCIENCE ENSORSEMENT PROGRAM, dated May 15, 2014, be REPEALED and a new rule with the same number and the same title be INITIATED. Program standards have been updated to align with A Framework for K-12 Science Education (2012).

• Chair Luigs announced that she will try to highlight some of the work being done in Georgia in her report. Today, Dr. Marti Venn spoke briefly about Bright Spots – National Recognition for Georgia. The National Association of State Directors of Teacher Education and Certification had a conference in which the PSC conducted numerous sessions and received many accolades as being 1st in moving the nation

B. Educator Preparation Standing Committee

Committee Chair, Dr. Marti Venn, presented the report of the Educator Preparation Standing Committee.

1.	Cobb County Schools	The Committee recommends Continuing Approval of the Educator Preparation Provider and the Gifted In-field Endorsement. Additionally, the Committee recommends Developmental Approval of the Teacher Support and Coaching, and Teacher Leader Endorsement Programs.
2.	Kennesaw State University	The Committee recommends the Progress Report submitted April 9, 2015, is satisfactory in addressing the area for improvement for Standard 4 (element d) resulting from the Fall 2012 Continuing Approval Review. The Committee recommends the area for improvement be removed.
3.	Tier II Appeal Mary Elizabeth Smith	The Committee recommends granting the Educator's Tier II Certification Appeal request, increasing her certification status from Level 4 to Level 5.

VIII. <u>CAEP PARTNERSHIP AGREEMENT</u>

Angie Gant will present CAEP Partnership Agreement and take questions. The CAEP Task Force would like to propose the CAEP Partnership Agreement you have reviewed. There has been one key change that we made after we sent this agreement to you, and I want to note that now:

On page 3 of the document you received, under letter C (numbers 1, 2, and 3), the statements should begin with "If the CAEP Board decides," rather than "If the Site Visit Team recommends."

If you approve this agreement, we will submit it to CAEP leadership and await their approval of the agreement. I should point out that the following items may be ones with which CAEP could disagree:

- 1. On page 2 (number 4), CAEP has stated that they will not allow the Site Visit Team to make recommendations to the CAEP Board. (The CAEP Board will review the Site Visit Team findings, and the CAEP Board will make a decision.) The Site Visit Team is only allowed to present findings to the institution at the end of the visit.
- 2. On page 3 (7a), you find a definition for advanced programs. CAEP's definition differs from our definition, which leads to the next item with which CAEP might disagree, and that is number 8. CAEP may very well determine that they want to review advanced programs.
- 3. On page 5 (letter A), we state that the national team cannot contain more than 50% of the entire team.
- 4. Also on page 5, (letter I) might cause some concern because our program approval specialists will determine the size of the state team.
- 5. On page 6, letter A under "Other Terms and Conditions," we find information regarding Georgia staff member costs associated with trainings and clinics. CAEP may prefer that we pay for those.
- 6. On page 7, letter C, the task force wanted CAEP to provide complimentary registration for one person from each institution per year for conferences. They asked for this because they are all required to pay CAEP fees each year.

IX. STANDARD SETTING EdTPA

Anne Marie Fenton presented the Standard Setting EdTPA.

MOTION: (Dr. Larry Walters / Valerie Mateen) To initiate the standard setting for the edTPA content pedagogy assessment. a) For 2015-2016, score reports that are dated September 1, 2015, to August 31, 2016, must reflect a score of 35 points or higher on edTPA in fields with 15 rubrics to be considered passing edTPA in Georgia, which is minus ½ standard error of measurement below the Georgia edTPA standard setting committee recommendation. The passing scores for the 13 rubric fields will be 29 or higher, and the passing score in 18 rubric fields will be 42 or higher; b) For 2016-2017, score reports that are dated September 1, 2016, to August 31, 2017, must reflect a score of 35 points or higher on edTPA in fields will be 29 or higher, and the passing score in 18 rubric fields will be 42 or higher; c) For 2017-2018, score reports that are dated September 1, 2017, to August 31, 2018, must reflect a score of 38 points or higher on edTPA in fields with 15 rubrics to be considered passing edTPA in Georgia, which is equal to the recommended passing score of the edTPA Georgia standard setting committee.
