11. REVIEW HEARING EXTENSIONS

The Commission reviewed the *Review Hearing Extensions Report* concerning 5 hearing cases. An Administrative Law Judge rendered Initial Decisions on each case referenced in the report. The report indicates Orders were issued.

12. STUDENT LOAN SUSPENSION / REINSTATEMENTS

The Commission reviewed the report, which indicated that there were 12 certificates suspended from May 10, 2007 through June 14, 2007. There were 14 certificates that had been *reinstated* because restitution is now being made on those student loans. The Committee was also advised that there were 8 issues where notification had been received to suspend but releases were received prior to the actual suspension being implemented. Restitution is now being made on those student loans.

Dr. Fran Watkins presented the Educator Preparation rules to the commission. <u>MOTION</u>: (Smith / Powell) To amend the current rules in Chapter 505-3 (Educator Preparation), effective July 15, 2007, as follows: 505-3-.12, 505-3-.64 and 505-3-.78. <u>ACTION</u>: Approved

B. The Office of Planning and Budget will allow commissioners to have their choice of receiving their travel reimbursement by check or direct deposit. An authorization agreement for electronic funds transfer for travel form was given to all commissioners.

C. Dr. Toth spoke about the Professional Standards Commission's reorganization and gave the commissioners a copy of the re-organizational charts. He stated that the Professional Standards Commission is a Regulatory Agency charged with establishing and enforcing standards for Educator Preparation, Certification and Professional Conduct. The purpose of the Professional Standards Commission is to provide a pool of qualified educators to serve the children of Georgia. He also spoke about three new positions for recruiters that have been created.

IX. <u>CHAIR REPORT</u>

Dr. Wilkes presented the following:

A. Dr. Wilkes, Maria Bradley and Rose Powell attended the National Association of State Directors of Teacher Educational and Certification (NASDTEC) conference held in Salt Lake City, Utah. One of the sessions held featured Mark Tucker from the National Center on Education and the Economy who spoke on their recent report titled "Tough Choices, Tough Times". This report was given to all the commissioners. Dr. Wilkes felt that it was a valuable report and indicated that she would like to discuss it at the November commission meeting, which will be held in Brasstown. Rose Powell also spoke briefly about the conference and expressed her gratitude for having the opportunity to attend.

B. Maria Bradley has been chosen to serve on Johnny Isaakson's Education Commission.

C. Hester Vasconcelos spoke briefly about Salamanca University, which is located in Spain. Professors from Salamanca University will be offering a Masters degree in Spanish Pedogogy this summer in Georgia.
