I. WORK SESSION

- Kelly Henson welcomed Teri Schneider to the Commission. Teri is an Advanced Placement (AP) Environmental Science and Pre-AP Biology teacher at Peachtree ridge high School in Gwinnett County. She is certified as a Georgia Master Teacher and is an AP Environmental Science Exam grader for College Board/ETS and has presented at the AP National Conference in 2014 and 2015. At Peachtree Ridge High School she is involved with the school's SACS accredited STEM program, is the gifted testing coordinator and is the assistant coach for the seven time state champion competition cheer team. She earned her bachelor's degree from Anderson University. She has two children, one grandchild and resides in Suwanee.
- Kelly welcomed Diane Bailey, Vice President for Teacher Licensure and Certification, ETS and Clyde Reese, Principal Research Project Manager at the Center for Foundational and Validity Research.
- Kelly Henson and Kami Luigs welcomed back former Commissioner Pam Walker, thanked her for her service and presented her with her picture. Pam was a Commissioner from 2010 2015 and Chair of the Ethics Committee beginning in July 2012. She was also a State Teacher of the Year. She applied her knowledge of teachers and teaching and her vast experience to the ethics cases that we considered. Pam understands what reasonable ethical expectations are for teachers and leaders and she utilized this understanding to help us fairly decide thousands of cases. Pam was thoughtful, thorough and dedicated to our work.
- Kelly received a request from a Commissioner that our notes be more inclusive i.e. such as stating the reasons a Commissioner gave for voting as he/she did and the content of discussions on cases. The following was researched: a) Kelly looked at other states' minutes. Many gave less information than we give; and b) Kelly spoke to Rebecca Mick and Tanis Miller. They both said that we are already exceeding what is required by law. Kelly's thoughts were that this would not be a change we would want to make for the following reasons: a) The minutes would be subject to the interpretation of the person taking the notes; b) There is no compelling reason to do it. If Commissioners receive questions outside of our meeting they should direct those to PSC staff; c) potentially place Commissioners at risk

relative to litigation based on what was placed in the notes. For these reasons the minutes will remain the same.

• Chair Report – Chair Luigs spoke briefly about Kelly Henson's performance review. She received glowing feedback from staff. The executive committee met and commented on Kelly's ability to listen to different stakeholders. A letter was sent to the Governor with the results.

Dr. Marti Venn presented Bright Spot – In our mother rule 505-3-.01, the PSC encourages partnerships between higher education and school districts. A bright spot presented this morning shows evidence of that work. Georgia Regents University has launched a partnership with 29 schools in Richmond County to prepare teachers in classroom settings for K-12. Their work recently received some nice press (article was given to Commissioners). Along with Richmond County, Georgia Regents University has partnerships with Columbia, Burke, Jefferson, Warren and McDuffie counties to foster similar programs. These partnerships are a win-win for the districts, college students and kids.

• Anne Marie Fenton presented rule for adoption. Commissioners will be asked to adopt all rules that were initiated on July 9th with an effective date of October 15, 2015. No comments were received during the public comment period.

Discussion (Certification)

505-2-.05 PROFESSIONAL CERTIFICATE

AMEND to clarify experience requirements for renewal of the Performance-Based Professional certificate. Makes it so that Proficient/Exemplary TKES ratings used for renewal of a PRT may have been earned on any GA certificate.

505-2-.07 LEAD PROFESSIONAL CERTIFICATE

AMEND to clarify that any pre-requisite certificates must be valid, renewable, and professional in order to qualify for the Lead Professional certificate and to update the name of the Teacher Support and Coaching endorsement.

505-2-.23 CERTIFICATE OF ELIGIBILITY

AMEND to clarify the requirements for reissuance of a Certificate of Eligibility that is not converted to a full certificate prior to its expiration date.

505-2-.25 EXPERIENCE REQUIREMENTS

AMEND to further define acceptable P-12 settings for educator experience.

505-2-.26 CERTIFICATION AND LICENSURE ASSESSMENTS

AMEND to clarify the assessment requirements for Permit holders converting to Induction or Professional certificates. Clarifies that foreign language Permit holders must pass GACE (if available) for conversion to Induction or Professional.

505-2-.31 GaPSC-ACCEPTED ACCREDITATION: VALIDATION OF NON-ACCREDITED DEGREES

AMEND with the new name of "GaPSC-ACCEPTED ACCREDITATION FOR CERTIFICATION PURPOSES" to define acceptable accreditation for P-12 educational settings.

505-2-.32 VALIDITY PERIODS AND DATING OF CERTIFICATES

AMEND to clarify the effective dates of different types of certificates and licenses.

505-2-.34 ADD A FIELD

AMEND to allow for issuance of a Supplemental Induction certificate in the fields of Early Childhood Education and Special Education General Curriculum/Early Childhood Education, in accordance with a change in Rule 505-2-.04 INDUCTION CERTIFICATE that has already been adopted.

505-2-.36 RENEWAL REQUIREMENTS

AMEND to establish that PLUs and CEUs awarded on or after 1/1/16 will not be acceptable for renewal credit, to clarify the requirements for acceptable PLUs, and to clarify the date after which educators must be employed or have Georgia experience in order to renew their certificates.

505-2-.44 RETIRED EDUCATOR CERTIFICATE – new rule

ADOPT this new rule to create a new certificate type. This certificate will allow retired educators to quality as top priority substitute teachers without having to fulfill renewal requirements (such as college credit or retesting).

505-2-.91 COMPUTER SCIENCE – new rule

ADOPT this new rule to create a new certificate field.

505-2-.148 SPEECH AND LANGUAGE PATHOLOGY

AMEND to adjust the numbering in section (5)(a)2.

505-2-.179 SPECIAL EDUCATION VISUAL IMPAIRMENT ENDORSEMENT

AMEND to change the base certificate requirements in accordance with a change in program admission requirements.

505-2-.182 TEACHER SUPPORT AND COACHING ENDORSEMENT

AMEND to eliminate the option for a Supplemental Induction (SI) endorsement. The option for the SI is being removed because educators who hold Induction certificates may not be admitted to GaPSC-approved Teacher Support and Coaching Endorsement programs (See GaPSC Educator Preparation Rule 505-3-.105 TEACHER SUPPORT AND COACHING [TSC] ENDORSEMENT).

505-2-.184 DUAL IMMERSION EARLY CHILDHOOD EDUCATION ENDORSEMENT - new rule

ADOPT this new rule to create an endorsement that will allow qualified foreign language teachers to teach Early Childhood Education in dual immersion schools.

Educator Preparation:

505-3-.48 FOREIGN LANGUAGE EDUCATION PROGRAM

REPEAL and that a new rule with same number and the same title be ADOPTED. The new rule is intended reflect changes in the standards published by the American Council on the Teacher of Foreign Languages.

505-3.56 SPECIAL EDUCATION GENERAL CURRICULUM EARLY CHILDHOOD EDUCATION PROGRAM (P-5)

REPEAL and that a new rule with the same number and the same title be ADOPTED. The new rule involves the adoption of the standards by the Council for Exceptional Children 2012.

505-3-.61 AUTISM EDUCATION ENDORSEMENT PROGRAM – NEW RULE

ADOPT this new rule to prepare both general education and special educators to work with students with Autism. This endorsement does not qualify general education teachers to be the teacher of record for special education students.

505-3-.93 K-5 SCIENCE ENSORSEMENT PROGRAM

REPEAL and a new rule with the same number and the same title be ADOPTED. Program standards have been updated to align with A Framework for K-12 Science Education (2012).

• Anne Marie Fenton presented 14 Certification Rules and 5 Educator Preparation Rules that will come before you for initiation in October.

Kelli Young previewed the Certification Rules. Angie Gant previewed 4 of the Educator Preparation Rules. Julie Beck previewed the GaTAPP Educator Preparation Rule.

Certification:

505-2-.01 GEORGIA EDUCATOR CERTIFICATION

It is proposed that GaPSC Rule 505-2-.01 GEORGIA EDUCATOR CERTIFICATION, dated July 1, 2014, be AMENDED to expand the definition of certificated personnel, and to clarify which public school personnel are required to hold GaPSC certification or licensure.

505-2-.02 CLASSIFICATION

It is proposed that GaPSC Rule 505-2-.02 CLASSIFICATION, dated April 15, 2015, be AMENDED to accommodate the new Retired Educator certificate, proposed to go into effect on October 15, 2015; and to establish a procedure for assigning leader levels to Georgia educators who earned certification through interstate reciprocity prior to January 15, 2016 and subsequently earn Educational Leadership certification based on a degree that was held at the time of initial Georgia certification under the requirements of Rule 505-2-.153 EDUCATIONAL LEADERSHIP, proposed to go into effect on January 15, 2016.

505-2-.03 PRE-SERVICE TEACHING CERTIFICATE

It is proposed that Rule 505-2-.03 PRE-SERVICE TEACHING CERTIFICATE, dated July 1, 2015, be AMENDED to clarify that a Pre-Service certificate is not required for candidates who already hold a teaching certificate.

505-2-.04 INDUCTION CERTIFICATE

It is proposed that GaPSC Rule 505-2-.04 INDUCTION CERTIFICATE, dated June 15, 2015, be AMENDED to clarify that an applicant who completed student teaching in Georgia may not qualify for an Induction Pathway 3 certificate even if they become certified in another state; to outline a content testing exemption for GaTAPP candidates qualifying for Induction Pathway 4 certificates; and to clarify that enrollment in an educator preparation program is not required for issuance of an Induction Pathway 4 certificate; and to remove redundant information.

505-2-.20 SUBSTITUTE TEACHING

It is proposed that GaPSC Rule 505-2-.20 SUBSTITUTE TEACHING, dated July 1, 2014, be AMENDED to add the Retired Educator Certificate, proposed to go into effect on October 15, 2015, to the highest priority group for substitute teaching.

505-2-.22 CERTIFICATION BY STATE-APPROVED PROGRAM

It is proposed that GaPSC Rule 505-2-.22 CERTIFICATION BY STATE-APPROVED PROGRAM, dated January 15, 2015, be AMENDED to clarify the requirements for cooperating teachers of out-of-state program candidates who complete clinical practice requirements in Georgia.

505-2-.32 VALIDITY PERIODS AND DATING OF CERTIFICATES

It is proposed that GaPSC Rule 505-2-.32 VALIDITY PERIODS AND DATING OF CERTIFICATES, dated October 15, 2015, be AMENDED to add the validity period of the new Retired Educator Certificate, proposed to go into effect on October 15, 2015.

505-2-.33 CERTIFICATE UPGRADE

It is proposed that GaPSC Rule 505-2-.33 CERTIFICATE UPGRADE, dated April 15, 2015, be AMENDED to clarify the requirements for degrees to qualify for a grandfathering period and to establish a new procedure for evaluating advanced degrees started by out-of-state educators prior to becoming certified in Georgia through reciprocity.

505-2-.36 RENEWAL REQUIREMENTS (2017 version)

It is proposed that GaPSC Rule 505-2-.36 RENEWAL REQUIREMENTS, dated July 1, 2017, be AMENDED to add Continuing Education Units as an option for renewal coursework earned by educators who are note employed; to clarify the renewal requirements for educators employed by Georgia private schools; and to clarify the renewal requirements for educators who are not employed at the time of renewal but have been employed within the five years prior to the renewal date.

505-2-.43 ANNUAL PERFORMANCE EVALUATION

It is proposed that Rule 505-2-.43 ANNUAL PERFORMANCE EVALUATION, dated July 1, 2014, be AMENDED to clarify the requirements to remediate unsatisfactory performance ratings and the restrictions on certificate issuance to educators who have earned 2 unsatisfactory performance ratings; and to make a change to the requirements for remediating an unsatisfactory performance rating with a subsequent satisfactory rating.

505-2-.102 READING SPECIALIST

It is proposed that GaPSC Rule 505-2-.102 READING SPECIALIST, dated July 1, 2014, be AMENDED to allow for issuance of an Induction certificate in this field.

505-2-.153 EDUCATIONAL LEADERSHIP CERTIFICATE

It is proposed that GaPSC Rule 505-2-.153 EDUCATIONAL LEADERSHIP CERTIFICATE, dated July 3, 2014, be RESCINDED and that a new rule with the same name and number be INITIATED to establish certification requirements under the new Educational Leadership preparation and certification structure established by GaPSC Rules 505-3-.76 and 505-3-.77, which became effective on April 15, 2015.

505-2-.162 COACHING ENDORSEMENT

It is proposed that GaPSC Rule 505-2-.162 COACHING ENDORSEMENT, dated July 1, 2014, be AMENDED to eliminate the option for a Supplemental Induction (SI) endorsement. The option for the SI is being removed because educators who hold Induction certificates may not be admitted to GaPSC-approved Coaching Endorsement programs (See GaPSC Educator Preparation Rule 505-3-.85 COACHING ENDORSEMENT PROGRAM).

505-2-.181 TEACHER LEADER ENDORSEMENT

It is proposed that GaPSC Rule 505-2-.181 TEACHER LEADER ENDORSEMENT, dated July 1, 2014, be AMENDED to eliminate the option for a Supplemental Induction (SI) endorsement. The option for the SI is being removed because educators who hold Induction certificates may not be admitted to GaPSC-approved Teacher Leader Endorsement programs (See GaPSC Educator Preparation Rule <u>505-3-.104 TEACHER LEADER ENDORSEMENT</u> <u>PROGRAM</u>).

Educator Preparation:

505-3-.01 REQUIREMENTS AND STANDARDS FOR APPROVING EDUCATOR PREPARATION PROVIDERS AND EDUCATOR PREPARATION PROGRAMS

It is proposed that GaPSC Rule 505-3-.01 REQUIREMENTS AND STANDARDS FOR APPROVING EDUCATOR PREPARATION PROVIDERS AND EDUCATOR PREPARATION PROGRAMS, dated October 15, 2014, be REPEALED and a new rule with the same name and number INITIATED.

505-3-.02 EDUCATOR PREPARATION PROVIDER ANNUAL REPORTING AND EVALUATION

It is proposed that GaPSC Rule 505-3-.02 EDUCATOR PREPARATION PROVIDER ANNUAL REPORTING AND EVALUATION, dated July 3, 2014, be REPEALED and a new rule with the same name and number INITIATED.

505-3-.77 EDUCATIONAL LEADERSHIP PROGRAM

It is proposed that GaPSC Rule 505-3-.77 EDUCATIONAL LEADERSHIP PROGRAM, be AMENDED.

505-3-.76 ALTERNATIVE PREPARATION FOR EDUCATIONAL LEADERSHIP PROGRAM

It is proposed that GaPSC Rule 505-3-.60 ALTERNATIVE PREPARATION FOR EDUCATIONAL LEADERSHIP PROGRAM be AMENDED.

505-3-.05 GEORGIA TEACHER ACADEMY FOR PREPARATION AND PEDAGOGY (GaTAPP)

It is proposed that GaPSC Rule 505-3-.05 GEORGIA TEACHER ACADEMY FOR PREPARATION AND PEDAGOGY (GaTAPP), dated July 3, 2014, be REPEALED and a new rule with the same name and number INITIATED.

VII. STANDARD SETTING FOR COMPUTER SCIENCE GACE

Anne Marie Fenton presented the following:

There is a need for a new assessment in Georgia in the field of computer science. Today, you will be asked to set the passing standard for the Computer Science GACE. Georgia IHEs are not producing enough computer science graduates resulting in a negative economic impact on statewide business and industry. As the GaDOE strives to continue with a concentration on career readiness, it is imperative that computer science is a focus in that effort by preparing students to enter college with a desire to major in computer science. Beginning with the 2015-2016 school year, computer programming courses will be offered to satisfy core requirements in math, science and foreign language. A computer science pathway will be developed in the 2016-2017 school year. In order to accomplish this work, there must be educators qualified and certified to teach computer science courses. Currently, there are a limited number of educators certified in computer science. There is a computer science endorsement program offered by two institutions; however, these programs cannot prepare the number of educators needed in this field. Therefore, development of the computer science test is essential to meeting this critical need.

Clyde Reese, Principle Research Project Manager, ETS, gave a presentation with background information on the Computer Science GACE, as well as the recommendation of the standard setting committee.

MOTION: (Phil Jacobs / David Smith) For the Computer Science GACE two passing scores to be set at the following:

• Professional: at a value equal to the passing score recommended by the April 2015 Multistate Standardsetting Panel

• Induction: at a value equal to two conditional standard errors of measurement lower than the passing score recommended by the April 2015 Multistate Standard-setting Panel

IX. <u>PREVIEW OF GEORGIA ETHICS ASSESSMENT FOR EDUCATIONAL LEADERSHIP</u> <u>STANDARD SETTINGS</u>

Anne Marie Fenton presented the following:

We all know the importance of ethical leadership in our schools, and, as you know, we are working with ETS to develop a Georgia Ethics for Educational Leadership Assessment, closely aligned with the assessment for teachers yet customized for leaders. The assessment, eventually offered at two levels – Program Entry (Test 370) and Program Exit (Test 380), includes the critical role of the leader in fostering professionalism and building a positive school culture and also focuses on the unique ethical challenges educational leaders face.

Although it will not be required until July 1, 2016, the Georgia Ethics for Educational Leadership Assessment -Program Entry (Test 370) will be available to EPPs and their candidates on September 30, 2015. It is our hope that EPPs will encourage their educational leadership candidates to take the assessment. Data from the assessment will be made available to EPPs to guide their programs and preparation.

Timeline:

September 30, 2015: The Georgia Ethics for Educational Leadership Assessment– Program Entry (Test 370) becomes available for EPP optional use. We encourage EPPs to strongly encourage their educational leadership candidates to take it for their benefit.

July 1, 2016: All candidates admitted to any GaPSC-approved Educational Leadership program (current program or the new tiered model) on or after July 1, 2016, must have completed (do not have to pass) the Georgia Ethics for Educational Leadership Assessment – Program Entry (Test 370) prior to becoming enrolled and actively taking coursework in that program. A candidate who completes this program entry requirement (Test 370) for Tier I, does not have to complete Test 370 for Tier II.

All candidates completing any GaPSC-approved Educational Leadership program (current program or the new tiered model) on or after July 1, 2016, must attempt the Georgia Ethics for Educational Leadership – Program Exit (Test 380) prior to completion and must pass the assessment to earn certification in the field of Educational Leadership. A candidate who passes the Program Exit (Test 380) for Tier I certification, does not have to pass Test 380 for Tier II certification.

We will bring the standard setting decision to you in November. Clyde Reese, ETS, will present the standard setting process for the Georgia Ethics for Educational Leadership.
