I. WORK SESSION

- Kelly and Chair Luigs welcomed the three new commissioners. 1) Amanda is a teacher and instructional coach for the Houston County School System. She sits on the advisory board for the Georgia Partnership for Excellence in Education and is a member of the leadership task force for Kappa Delta Pi. She was named the 2015 Georgia Teacher of the Year and received the Innovation in Teaching Award in 2014. She was also named a global fellow for the National Education Association. Amanda earned a bachelor's degree from Valdosta State University and a master's degree and education specialist degree from Georgia Southwestern State University. She and her husband, Kellen, have two children and reside in Kathleen. 2) Christy is a middle school language arts teacher and a member of the middle school leadership committee for the Columbia County School District. She was named the Columbia County Teacher of the Year in 2012. Christy earned a bachelor's degree from Armstrong State University, a master's degree from Georgia Southwestern University and an education specialist degree from Augusta State University. She and her husband, James, have three children and live in Evans. 3) Leon is a pre-engineering teacher at Marietta High School and a U.S. Marine Corps veteran. He was named the 2016 Employee of the Year by Marietta City Schools and received a 2015 Educator Award from DiscoverE Education. Leon earned a bachelor's degree in Mechanical Engineering and a master's degree in Christian Education and Biblical Studies from Dallas Theological Seminary. Leon and his wife, Vickie, have three children and one grandchild. They live in Acworth.
- Kelly and Kristina spoke briefly about the October retreat logistics, topics of discussion and events.
- Dr. David Hill and Nate Thomas gave the following update on the School Counseling Task Force: In 2014 Georgia sent a delegation to participate in the First Lady's convening of the Reach Higher Initiative focused on college and career readiness and access and the school counselor role. Following this national meeting, the Georgia House established a study committee and developed recommendations on the role of school counselors in 2015; 7 recommendations impact GaPSC Preparation & Certification rules. The GaPSC established a task force of P-12 school counselors, School Counseling faculty, Educational Leadership faculty, GaDOE, GaPSC Certification staff, Representative Chandler who

chaired the House Study Committee, Southern Regional Education Board, RESA, and many are Georgia School Counselors of the Year as well as board members of the Georgia School Counselor Association.

• Adoption of Rules – Anne Marie Fenton previewed rules for adoption with effective date of October 15, 2016 that were initiated on July 14, 2016, as well as public comments.

For the Rules Adoption

505-2-.08 CAREER, TECHNICAL AND AGRICULTURAL EDUCATION

It is proposed that GaPSC Rule 505-2-.08 CAREER, TECHNICAL AND AGRICULTURAL EDUCATION, dated June 15, 2016, be AMENDED to include language on qualifying for a Non-Renewable, International Exchange, Permit and Adjunct license; and to add the option of a Permit for Healthcare Science, Engineering and Technology, and Career and Technical Specializations.

505-2-.10 PERMIT

It is proposed that GaPSC Rule 505-2-.10 PERMIT, dated July 1, 2014, be AMENDED to add the option for the fields of Career and Technical Specializations, Engineering and Technology, and Healthcare Science; and to add that the Online Teaching Endorsement may be added to a Permit in a teaching field.

505-2-.13 WAIVER CERTIFICATE

It is proposed that GaPSC Rule 505-3-.07 WAIVER CERTIFICATE, dated April 15, 2016, be AMENDED to clarify the purpose to include candidates completing programs leading to Induction Pathway One and Induction Pathway Two certificates missing assessment requirements for certification; and to update Highly Qualified information.

505-2-.26 CERTIFICATION AND LICENSURE ASSESSMENTS

It is proposed that Rule 505-2-.26 CERTIFICATION AND LICENSURE ASSESSMENTS, dated June 15, 2016, be AMENDED to clarify acceptable Content Pedagogy assessments and exemptions.

505-2-.32 VALIDITY PERIODS AND DATING OF CERTIFICATES

It is proposed that GaPSC Rule 505-2-.32 VALIDITY PERIODS AND DATING OF CERTIFICATES, dated January 15, 2016, be AMENDED to remove the exception for Non-Renewable Professional validity period based on reciprocity for field of Educational Leadership, to clarify Non-Renewable Professional validity period for the field of Educational Leadership, and to clarify numbering of sections.

505-2-.43 ANNUAL PERFORMANCE EVALUATION

It is proposed that GaPSC Rule 505-2-.43 ANNUAL PERFORMANCE EVALUATION, dated January 15, 2016, be AMENDED to clarify reporting accountability of unsatisfactory performance.

505-2-.44 RETIRED EDUCATOR CERTIFICATE

It is proposed that GaPSC Rule 505-2-.44 RETIRED EDUCATOR CERTIFICATE, dated October 15, 2015, be AMENDED to include an option for educators retired from private schools.

505-2-.87 HEALTHCARE SCIENCE

It is proposed that GaPSC Rule 505-2-.87 HEALTHCARE SCIENCE, dated October 15, 2014, be AMENDED to include an option for educators to hold a Permit certificate.

505-2-.89 ENGINEERING AND TECHNOLOGY

It is proposed that GaPSC Rule 505-2-.89 ENGINEERING AND TECHNOLOGY, dated January 15, 2015, be AMENDED to include an option for educators to hold a Permit certificate.

505-2-.90 CAREER AND TECHNICAL SPECIALIZATIONS

It is proposed that GaPSC Rule 505-2-.90 CAREER, TECHNICAL SPECIALIZATIONS, dated June 15, 2016, be AMENDED to add the fields of Computer Animation and Industrial Maintenance; and to revise entry degree requirements for Distribution and Logistics.

505-2-.153 EDUCATIONAL LEADERSHIP CERTIFICATE

It is proposed that GaPSC Rule 505-2-.153 EDUCATIONAL LEADERSHIP CERTIFICATE, dated January 15, 2016, be AMENDED to revise the date the Performance-Based Assessment for School Leaders is required for Tier II program completers.

Discussion (Educator Preparation):

505-3-.01 REQUIREMENTS AND STANDARDS FOR APPROVING EDUCATOR PREPARATION PROVIDERS AND EDUCATOR PREPARATION PROGRAMS

It is proposed that Rule 505-3-.01, REQUIREMENTS AND STANDARDS FOR APPROVING EDUCATOR PREPARATION PROVIDERS AND EDUCATOR PREPARATION PROGRAMS, dated October 15, 2014, be REPEALED and a new rule with the same number and title be INITIATED. The new rule addresses needed improvements and enhancements for educator preparation programs, represents adjustments for the implementation of tiered certification, and incorporates requirements related to new assessments.

505-3-.05 GEORGIA TEACHER ACADEMY FOR PREPARATION AND PEDAGOGY (GaTAPP)

It is proposed that GaPSC Rule 505-3-.05 GEORGIA TEACHER ACADEMY FOR PREPARATION AND PEDAGOGY (GaTAPP), dated July 3, 2014, be REPEALED and a new rule with the same name and number be INITIATED to align with the proposed GaPSC Rule 505-3-.01 REQUIREMENTS AND STANDARDS FOR APPROVING EDUCATOR PREPARATION PROVIDERS AND EDUCATOR PREPARATION PROGRAMS. This rule allows for the addition of Early Childhood Education (ECE) certification to an existing level four (4) or higher Professional teaching certificate after completion of a one year supervised Early Childhood Education Certification-only Program through GaTAPP.

505-3-.44 ART EDUCATION PROGRAM

It is proposed that Rule 505-3-.44 ART EDUCATION PROGRAM, dated May 15, 2014, be REPEALED and a new rule with the same name and number be INITIATED. Changes to the rule are intended to reflect revisions to the standards published by the National Association of Schools of Art.

505-3-.45 DANCE EDUCATION PROGRAM

It is proposed that the 505-3-.45 DANCE EDUCATION PROGRAM Rule, dated May 15, 2014, be REPEALED and that a new rule with the same number and title be INITIATED. The new rule is adapted from the National Association of Schools of Dance (NASD) and reflects current terminology and language relative to the field of Dance.

505-3-.46 THEATRE EDUCATION PROGRAM

It is proposed that Rule 505-3-.46 DRAMA EDUCATION PROGRAM, dated May 15, 2014, be REPEALED and that a new rule with the same number and a new name entitled THEATRE EDUCATION PROGRAM be INITIATED. The new rule is intended to reflect revisions to the National Association of Schools of Theatre.

505-3-.50 MUSIC EDUCATION PROGRAM

It is proposed that Rule 505-3-.50 MUSIC EDUCATION PROGRAM, dated May 15, 2015, be AMENDED. Changes to the rule are intended to reflect revisions to the National Association of Schools of Music Standards. 505-3-.94 STEM EDUCATION ENDORSEMENT PROGRAM

It is proposed that a GaPSC Rule 505-3-.94 STEM EDUCATION ENDORSEMENT PROGRAM, be INITATED as a new rule with a new number to prepare educators to use the principles of STEM education in their teaching practice.

505-3-.107 DUAL IMMERSION EARLY CHILDHOOD EDUCATION ENDORSEMENT PROGRAMIt is proposed that GaPSC Rule 505-3-.107 DUAL IMMERSION EARLY CHILDHOOD EDUCATION ENDORSEMENT PROGRAM, be INITIATED as a new rule with a new number to prepare educators certified in P-12 Foreign Language Education to be highly qualified to teach in P-5 Dual Immersion Classrooms.
