# NOTICE

- SUBJECT: Notice of Proposed Rulemaking

Notice is hereby given that, pursuant to the authority contained in Official Code of Georgia Title 20, it is proposed that the Professional Standards Commission initiate rulemaking procedures in accordance with Georgia Administrative Procedures Act so as to provide for (1) **amending** the current rules in Chapter 505-2 Certification, effective October 15, 2014, as follows: 505-2-.87, 505-2-.89, and 505-2-.90; (2) **rescinding** the current rules in Chapter 505-3 Educator Preparation, effective October 15, 2014, as follows: 505-3-.13, 505-3-.14, 505-3-.17, 505-3-.24, 505-3-.34, 505-3.35, 505-3.36, 505-3.37, 505-3-.38, 505-3.39, 505-3-.40, 505-3-.70, 505-3-.82, 505-3-.83, 505-3.84, 505-3.86, and 505-3.87; (3) **initiating** the current rules in Chapter 505-3.24, 505-3-.25, 505-3-.34, 505-3-.36, 505-3.37, 505-3-.38, 505-3-.39, 505-3-.14, 505-3-.14, 505-3-.24, 505-3-.25, 505-3-.34, 505-3-.36, 505-3.37, 505-3-.38, 505-3-.39, 505-3-.40, 505-3-.40, 505-3-.82, 505-3-.84, 505-3-.86, 505-3-.36, 505-3.37, 505-3-.38, 505-3-.39, 505-3-.40, 505-3-.40, 505-3-.25, 505-3-.34, 505-3-.36, 505-3-.37, 505-3-.38, 505-3-.39, 505-3-.40, 505-3-.40, 505-3-.25, 505-3-.34, 505-3-.36, 505-3-.37, 505-3-.38, 505-3-.39, 505-3-.40, 505-3-.82, 505-3-.84, 505-3-.86, 505-3-.87; (4) **amending** the current rules in Chapter 505-3 Educator Preparation, effective October 15, 2014, as follows: 505-3-.01; (5) **amending** the current rules in Chapter 505-6-.02.

All interested persons shall be afforded reasonable opportunity to submit data, views, or arguments orally or in writing. Anyone interested in making a written statement may do so by submitting it to the undersigned at 200 Piedmont Avenue, Suite 1702, Atlanta, Georgia 30334-9032. It is requested that such a statement be delivered on or before August 30, 2014. Opportunity for oral hearing shall be granted if requested by 25 persons who will be directly affected by the proposed rule, by a governmental subdivision, or by an association having not less than 25 members.

The Professional Standards Commission will consider the proposed rules during its regular meeting on September 11, 2014, to begin at approximately 12:00 noon at the Professional Standards Commission Board Room, 4<sup>th</sup> Floor, 200 Piedmont Avenue, Atlanta, Georgia 30334-9032.

It is proposed that GaPSC Rule 505-2-.01 REQUIREMENTS AND STANDARDS FOR APPROVING EDUCATOR PREPARATION PROVIDERS AND EDUCATOR PREPARATION PROGRAMS, dated July 3, 2014, be AMENDED to reflect a field name change.

#### 505-3-.13 BIRTH THROUGH KINDERGARTEN PROGRAM

It is proposed that GaPSC Rule 505-3-.13 BIRTH THROUGH KINDERGARTEN PROGRAM, dated May 15, 2014, be RESCINDED and that a new rule with the same name and number be INITIATED. The new rule is intended to reflect new standards.

# 505-3-.14 EARLY CHILDHOOD EDUCATION PROGRAM

It is proposed that GaPSC Rule 505-3-.14 EARLY CHILDHOOD EDUCATION PROGRAM, dated May 15, 2014, be RESCINDED and that a new rule with the same name and same number be INITIATED. The new rule is intended to reflect the adoption of new standards by the National Association for the Education of Young Children (2012).

#### 505-3-.17 ENGLISH EDUCATION PROGRAM

It is proposed that GaPSC Rule 505-3-.17 ENGLISH EDUCATION PROGRAM, dated May 15, 2014, be RESCINDED and that a new rule with the same name and new number of 505-3-.24, be INITIATED. The new rule reflects the adoption of new standards by the National Council of Teachers of English (NCTE) 2012.

#### 505-3-.24 MARKETING EDUCATION PROGRAM
