I. CALL TO ORDER/ROLL CALL

Chair Sirmans called the meeting to order at 4:00 p.m. and Commissioners answered roll call for attendance.

V. EXECUTIVE SECRETARY'S REPORT

The month of August is typically the start of a new school year for the majority of school districts in Georgia and by extension a busy time for Georgia Professional Standards Commission. We want to send our best wishes to all students, teachers and staff, and to administrators and our school systems across the State, for a wonderful school year!

Our first order of business is to officially welcome our newest Commission members just recently appointed and sworn in to office by Governor Kemp. I am going to call on each of the Commissioners by name, ask them to turn their cameras on, and introduce themselves. First on the list is Ms. Angela Byrne, then Ms. Christy Edwards, and last is Mr. Zach Miller. I also have the pleasure of publicly announcing that Ms. Jane Rookard

will be moving into the Vice Chair of the Education Preparation Program Committee. Ms. Byrne will be serving on the Ethics Committee and Mr. Miller and Ms. Edwards will be serving on the Educator Preparation and Certification Committee. I know all of our veteran members join with Chair Sirmans and me as we welcome each of our newest members to the Commission.

As we noted in our last report, we have been sharing information on the development of Ethical Considerations for Appropriate Use of AI by Educators in developing a set of guidance documents. We did discuss this new guidance work at the Summer GAEL conference. Quite a few districts let me know that the information provided important guidance for them. The generative evolution of AI will continue, and our work on this project will also continue as we consider professional development resources for systems to use. We have received feedback from the survey embedded in the document. This information, and more, will be included within the guidance supports to provide users with an ongoing opportunity to suggest any additions or enhancements, and to share helpful resources about avoiding missteps when using AI. To all of our systems, please do continue to share your thoughts via the embedded survey.

Our certification division continues to be busy with a huge rush of applications for initial certification, recertification, upgrades, etc. with the new GACE scores dropping this month. I'll speak more about this in a moment. Kudos to Dr. Kelli Young and her entire team for their tireless efforts, and their strong customer service with this important work in completing certification responsibilities.

The interview process continues for the new investigator positions, and these recommendations have been submitted to Ms. Fortenberry, our Director of Business Operations. The vetting process is underway, and we hope to have slots filled for the employees to start in September. Mr. Pumphrey and Ms. Fenton (Co-interim Directors) are continuing to keep our Ethics Division moving in the right direction. We will keep you updated on our search process.

The work with SR 237, the recruitment of and retention of educators, is ongoing. We had our first meeting with all agency heads and association leads on July 28. Some great foundational work of narrowing the focus on the group's strategic priorities was done. The Southern Regional Education Board (SREB) facilitated the day's work and then gave us homework to complete in preparation for our next meeting on August 27.

We shared the great news that the GACE implementation came on-line July 1, meeting the established target date. As a reminder the new GACE website is posted at www.gace.es.pearson, which includes costs, information about the new testlet models, preparation materials, FAQs, and more. We look forward to keeping you updated on the GACE as the implementation unfolds. As with any new technology implementation there may be a few "bugs" to work out, but we are pleased with these first steps. As I mentioned earlier, I am pleased to announce that the first GACE scores were posted on August 8. There is a lot of work that goes on behind the scenes to get the scores posted so that Certification and Ed Prep programs can utilize the data. We appreciate everyone's patience as we work with the new process.

Chairman Sirmans and I have confirmed having a face-to-face meeting in September where we can host a retreat for the entire Commission to meet our newest members and also provide orientation and training for our group. Details are still being worked out, but Ms. Shaat has pushed out a "Save the Date" notification and the agenda for our September 11th, meeting is being finalized. If you have suggestions for topics that you would like to learn more about, please let me know and we will work to include those requests.
