Kedrione Harris called the meeting to order at 10:00 a.m. and everyone recited the Pledge of Allegiance.

V. <u>EXECUTIVE SECRETARY'S REPORT</u>

Matt Arthur wished Dr. Holley Roberts a happy birthday. He mentioned that we are attending the Literary committee meetings and that he will provide Commissioners with updates periodically.

We hosted our 29th Annual Certification and Program Officials Conference on the mornings of November 30th and December 1st. Attendees included representatives of local school districts, RESAs, Georgia and out-of-state colleges and universities, and other state agencies. During the keynote address, Matt provided updates on the

educator workforce and our work on literacy. Four concurrent strands were offered over the two days, each featuring sessions focused on our core work of Certification, Educator Ethics, Educator Preparation, and Assessment. Exit survey results were very positive, with 75% of respondents saying the conference met, exceeded, or far exceeded their expectations. He thanked the planning team, comprised of representatives of each of our divisions, for their work on planning and delivering a highly engaging and beneficial conference.

VI. <u>RULES PREVIEW AND ADOPTION</u>

Windy Fortenberry presented the rules for preview and adoption. These rules, if adopted, will become effective January 1, 2024. Three public comments were received and they were included in the rule packet emailed to Commissioners.
