I. <u>CALL TO ORDER/ROLL CALL</u>

V. EXECUTIVE SECRETARY'S REPORT

Dr. Joseph Barrow gave the following report:

I thank you, again, for your unanimous approval of Governor Kemp's nomination of me as GaPSC's Executive Secretary. I am humbled by it. I also thank and recognize Mr. Matt Arthur for his leadership and service, which are to be commended. I've had a very busy, informative, and enjoyable six days in this new role. I've met with each director individually and collectively and have learned much – especially that there is so much more to learn! Having served in public education for 40 years, I have had many experiences in varying roles at the local school and district level, as well as serving in an educational organization. Having this opportunity to serve in a different role as agency head is refreshing to me professionally and personally. I look forward to bringing my knowledge and expertise from my prior roles to this one – yet know I will gain even more insight as I continue to serve Georgia education in a different way.

As a practitioner and supporter of prospective, new, and veteran educators throughout my career, I do understand and appreciate GaPSC's awesome charge. I have often been brought into an organization to fix something. Coming new into this role, the great news for me is GaPSC already has such a well-known high level of performance, efficiency, and collaboration. The agency is not "broken" and does not require immediate, massive, or emergency course corrections. I thank Matt and GaPSC's excellent staff for this, and I look forward to building on this solid work. The high level of commitment to quality customer service, the strong spirit of collaboration, the deep expertise and experience, and the dedication to ongoing continuous improvement are all highly evident in the staff. I look forward to getting to know and work with each of them, just as I do with you. Just as it is true across this profession, our agency will continue to face challenges, which I prefer to call "opportunities." Building trust with GaPSC staff and with you are important to me. Should we need to make adjustments over time, we will "make haste, slowly" and, as author Stephen Covey notes, "make changes at the speed of trust." To help identify and address potential enhancements, I have developed and will be refining a 90-Day plan. Part of that plan includes completing an environmental scan both internally and externally to learn more about not only what is – perceptions, attitudes, areas for growth, and suggestions about our work, but also what can, could, or should be to maximize our efficiency and service, as well as how we as an agency can contribute to the educator pipeline and effective education across our state. This will be a collaborative process, and I look forward to keeping you informed about the plan, including its progress and results.

As part of my report, I am including only one specific agency item. In the fall, you learned of test development and fairness review committees to help develop our new GACE program, which launches July 1, 2025. As an update, over 50 standard setting committees comprised of Georgia educators and those who prepare Georgia educators are now forming and will begin their work toward the end of January. We are currently seeking educators and program provider faculty to serve on these committees; the information is on our website. The committees' work will help inform your work in setting the passing standard for each GACE assessment. We will start this important process with you later in the Spring across several Commission meetings.

We are currently developing a system that will enhance our systems and services, and we are all looking forward to that work.

In closing, I embrace the agency's mission to "build the best prepared, most qualified, and most ethical education workforce in the nation." I look forward to this responsibility and opportunity and to our work together.

VI. RULES INITATION

Anne Marie Fenton presented one Certification rule and one Educator Preparation rule which were previewed at the December 12th Commission meeting. The rules listed below came before the Commission today for initiation.

Certification

505-2-.46 MILITARY SUPPORT CERTIFICATE - It is proposed that GaPSC Rule 505-2-.46 MILITARY SUPPORT CERTIFICATE, dated July 1, 2022, be AMENDED to include the professional certificate option based on the revised Servicemembers Civil Relief Act (SCRA), 50 U.S.C. §§ 4025a.

Educator Preparation

505-3-.06 PEDAGOGY-ONLY PROGRAM - It is proposed that GaPSC Rule 505-3-.06 PEDAGOGY-ONLY PROGRAM dated August 15, 2023, be AMENDED to clarify eligible fields and to exclude the field of Middle Grades reading.

MOTION: (Jeanine Bunn / Dr. Holley Roberts) To (1) amend the current rule in Chapter 505-2- Certification, effective April 15, 2025, as follows: 505-2-.46; and (2) amend the current rule in Chapter 505-3- Educator Preparation Rules, effective April 15, 2025, as follows: 505-3-.06.

PSC ACTION: Approved

The rules will be posted for a 30-day public comment period and then come back to Commissioners for their adoption consideration at the March 13th Commission meeting, with an effective date of April 15, 2025.

- Brenau University The Committee recommends Developmental Approval for the Speech-Language Associate Program (P-12) [Baccalaureate Degree].
- Clark Atlanta University The Committee recommends Developmental Approval for the Computer Science Endorsement Program.
- Henry County Schools As a result of incremental progress evident in the September 17, 2024, Progress Report, the Committee recommends all areas for improvement (AFIs) and unmet standards cited during the Spring 2023 Continuing Approval Review remain for the Educator Preparation Provider (EPP). The Committee recommends the submission of a progress report due October 8, 2025, addressing the remaining AFIs and unmet standards. The progress report should include performance data for the candidates that are enrolled in the Educator Preparation Provider (EPP). The progress report should provide evidence of the analysis of data from key assessments to demonstrate how the EPP uses data to inform operational effectiveness, and track candidate progress over time. The progress report should also indicate how the EPP assures a systematic and sequenced process for tracking field experiences in the Gifted In-field Endorsement program.
- Truett-McConnell University The Committee recommends granting the request for a one-year deferral of the Fall 2026 Continuing Approval Review to Fall 2027 for the EPP.
