## VII. RULES ADOPTION AND ORAL HEARING

Anne Marie Fenton brought the Professional Practices (Ethics) rule and Educator Preparation rules initiated by Commissioners at the June 8, 2023, Commission meeting, to them for their adoption consideration at this meeting. These rules, if adopted, will become effective August 15, 2023. Seven public comments were received during the public comment period, and were shared with Commissioners.

Chair Sirmans stated that we received a request for an oral hearing by an association having not less than 25 members during the public comment period, which will begin at this time.

Chair Sirmans called the oral hearing in the matter of the proposed rules initiated by the Commission on July 13, 2023, to order. A quorum of the Commission was present. He asked each Commission member to state their name for the record. Each Commissioner received all written comments.

Chair Sirmans announced that we would hear from members of the public. He asked that their statements be concise and limited to three (3) minutes. There were two speakers from the public. He asked Commissioners if they had questions. Hearing none he proceeded with the motion.

## **B.** Educator Preparation Standing Committee

Dr. Judi Wilson presented the report of the Educator Preparation Standing Committee.

- 1. Berry College The Committee recommends granting the request to defer the Fall 2026 Continuing Approval Review to Fall 2027.
- 2. Forsyth County Schools As a result of satisfactory progress indicated in the May 9, 2023, Progress Report, the Committee recommends removal of the area for improvement (AFI) in Standard 1.1 for the following endorsements cited during the Spring 2022 First Continuing Approval Review for the Educator Preparation Provider (EPP).
  - K-5 Mathematics Endorsement
  - Online Teaching Endorsement
  - Teacher Support and Coaching Endorsement
- 3. Gordon State College As a result of Satisfactory progress indicated in the April 6, 2023, Progress Report, the Committee recommends removal of the AFI in Standard 2.3 for the Educator Preparation Provider (EPP).

As a result of incremental progress evident in the April 6, 2023, Progress Report, the Committee recommends the following AFIs remain for the EPP.

- Standard 1.1
- Standard 3.5
- Standard 4.1

As a result of unsatisfactory progress evident in the April 6, 2023, Progress Report the Committee recommends the following AFIs remain for the EPP.

- Standard 4.2
- Standard 4.4
- Standard 5.1
- Standard 5.3
- Standard 5.4

Also, as a result of unsatisfactory progress, the AFI in Standard 6.4 remains for the following programs.

- English Education
- History Education
- Secondary Science Biology
- Special Education General Curriculum/Elementary Education

The Committee recommends the submission of a progress report due January 12, 2024, addressing all remaining AFIs. The progress report should include an analysis of all data referenced in the April 6, 2023, Progress Report. The progress report should also indicate multiple measures of data collection and analysis beyond the PPEM data also referenced in the April 6, 2023, Progress Report. In addition to the analysis of data, the progress report should indicate how the EPP is using its analysis of data to inform program improvement, and should include trends based on the analysis of data from key assessments.

4. Pioneer RESA – The Committee recommends Continuing Approval with Conditions for the EPP and the six educator preparation programs reviewed during the Spring 2023 Continuing Approval Review.

The Committee recommends the submission of a progress report due July 12, 2024, addressing the not met standards and areas for improvement cited during the Spring 2023 Continuing Approval Review.

Chair Sirmans called for approval of the Educator Preparation and Certification Committee report as presented by Dr. Judi Wilson.
