## I. WORK SESSION

- Kelly Henson spoke briefly about rules. The commissioners were all informed that we decided to pull Rule 505-3-.01 from the agenda. While we only received a very limited amount of public comment, we take public comment very seriously and when there are comments that we feel have some merit we will always take our time, do further investigation, and fully consider the comment before reinitiating the rule. It is our intent to have this rule before you in May or June.
- We will have the Commission retreat October 13-14, 2016. Kristina Stroede addressed retreat logistics briefly and reminded the commissioners that if they had topics that they would like to be covered to please send them in.
- Dr. David Hill gave a presentation on Professional Learning Update. He also gave the commissioners the GaPSC Professional Learning Workshop Participant Manual.
- Anne Marie Fenton presented the rules for initiation and adoption Certification
  - A. Repeal the current rules and adopt new rules as follows:
    - **505-3-.65 MEDIA SPECIALIST PROGRAM** The new rule is adapted from the American Library Association (ALA) and the American Association of School Librarians (AASL) Standards for Initial Preparation of School Librarians. Changes to the rule are considered substantive. The adapted rule reflects current terminology and language relative to the field of Library and Information Science.
    - **505-3-.90 GIFTED IN-FIELD EDUCATION ENDORSEMENT PROGRAM** The new rule is intended to reflect new standards by the Council for Exception Children (2012).
  - B. To amend with an effective date, if adopted, of June 15, 2016:
    - **505-2-.04 INDUCTION CERTIFICATE** to remove the option to use an academic major in place of a GACE content assessment for special education academic content concentration(s) on Supplemental Induction certificates and clarify that an Induction Pathway Four (4) certificate is not

issued to candidates in programs leading to Induction Pathway One (1) and Pathway Two (2) if Special Georgia Requirements are not completed.
