V. <u>EXECUTIVE SECRETARY'S REPORT</u>

This week is Teacher Appreciation Week which is a national holiday. I want to thank all of you that are in the classroom for your dedication and hard work.

I know that you have received emails from Renee regarding our transition from Teams meetings to Zoom webinars. We're doing this to provide a more stable and secure process for our monthly meetings, while maintaining "view only" access to the public. We would like to conduct the June Commission meeting, using the Zoom webinar platform. The committee meetings will still use the Teams platform in June, and will

transition to Zoom webinars in July assuming that we don't run into any roadblocks. I hope that you are able to attend the practice session after this meeting at 4:45. Please remember to reboot your computer before joining the Zoom webinar. If any of you can't attend this Zoom webinar demo, please contact Renee, and we'll be glad to set up another session before the June meeting.

We earlier shared with you our collaborative work with all 16 RESAs about the Paraprofessional Ethics Modules and showed you a promotional video we produced encouraging school districts to use them. The purpose of the modules is to help our state's paraprofessionals avoid ethical missteps by ensuring they know and are able to apply the Code of Ethics for Educators. The use of the modules, while not required by the state, is going well. As one example of this use, Heart of Georgia recently coordinated a celebration with Montgomery Elementary School (part of Montgomery County School District in Mount Vernon, GA) who had 100% of their paraprofessionals complete the modules. Each paraprofessional was individually recognized and received a framed certificate. We are all happy for them and their accomplishment. We continue to appreciate all 16 of Georgia RESAs' commitment to providing this structure of training and support to our state's paraprofessionals.

VI. RULES ADOPTION

Anne Marie Fenton presented the rules for Educator Preparation rules for adoption that were initiated at the March 14th Commission meeting. These rules, if adopted, will become effective June 15, 2024. No public comments were received.

MOTION: (Dr. Judi Wilson / Jordan Frobos) To amend the current rules in Chapter 505-3- Educator Preparation Rules, effective June 15, 2024, as follows: 505-3-.01, and 505-3-.76.

PSC ACTION: Approved

505-3-.01 REQUIREMENTS AND STANDARDS FOR APPROVING EDUCATOR PREPARATION PROVIDERS AND EDUCATOR PREPARATION PROGRAMS

It is proposed that GaPSC Rule 505-3-.01, REQUIREMENTS AND STANDARDS FOR APPROVING EDUCATOR PREPARATION PROVIDERS AND EDUCATOR PREPARATION PROGRAMS dated January 1, 2024, be AMENDED to: Clarify that candidates are responsible for applying for the Pre-Service Certificate; add EPP deadlines for entering in TPMS the beginning of clinical practice and supervising teacher Cert ID; revise the definition of LUA to make it consistent with the definition used in Certification rules; and to make non-substantive updates in terminology.

505-3-.76 ALTERNATIVE PREPARATION FOR EDUCATIONAL LEADERSHIP PROGRAM

It is proposed that GaPSC Rule 505-3-.76, ALTERNATIVE PREPARATION FOR EDUCATIONAL LEADERSHIP PROGRAM dated January 1, 2024, be AMENDED to clarify determination of leadership positions. Other edits are included to remove references to an outdated set of guidelines, and to make capitalization and other minor/non-substantive adjustments.
