#### I. <u>CALL TO ORDER/ROLL CALL</u>

Chair Sirmans called the meeting to order at 4:00 p.m. and Commissioners answered roll call for attendance.

#### V. EXECUTIVE SECRETARY'S REPORT

Dr. Joseph Barrow gave the following report:

I trust everyone has gotten off to a good start this May. As a long-time educator, I always appreciated the arrival of May because I knew summer break was just around the corner, we knew graduations were only a few weeks away, and that another year would be completed with a new group of young people moving out into "the real world," and a new crop of youngsters would be getting ready to advance. That is one of the great things about the education profession in that it moves in a complete cycle and even if you may have had a tough year, a new day and new opportunities are on the horizon.

May is also a special time because it is the moment where we pause and celebrate our staff because this week is designated as Public Employee Recognition Week. Governor Kemp acknowledges this week with a formal

proclamation, and I have also shared a letter with our team expressing my appreciation for their high-quality service. It is hard to believe this week marks the beginning of my fifth month at the PSC, but one of the things I quickly learned, as your Executive Secretary, is the agency's commitment to excellence. I want to share my appreciation to our entire team for their commitment to their craft.

A great example of this type of performance was held on April 23. The event was called our 2025 Teacher Pipeline Summit, hosted by Georgia College and State University. This work is rooted in SB 88 passed in 2021 and will closely align with SR 237 passed by the Senate in this past legislative session. Governor Kemp and the General Assembly recognized the need to recruit more teachers of color, but we also need more males, and frankly we just need more teachers in general because of the shortages of highly qualified professionals in our state. We had a standing room only crowd, with a great cross section of Georgians present; from legislators, education preparation programs, SDOE, USG representatives, current pre-service students, local systems, and finally, a number of our commissioners (Ms. Carol Williams, Dr. Holley Roberts, Ms. Jane Rookard, Dr. Jennifer Wade, and Ms. Abigail Coggins) and directors were in attendance. Based on the feedback I have received to date, the response has been very positive, and I want to commend Dr. McRoy, and particularly, Dr. PaQuita Morgan, being a driving force behind the project planning for the event, and the entire Ed Prep Program team for a job well done.

In light of the work involving Educator Recruitment and Retention, I did want to further mention we are in the process of meeting with all of the education agency and associations heads in the work urged by SR 237. This is a major and comprehensive body of work that will require a lot of collaboration, but I believe if the plan is well developed effectively funded, and implemented with fidelity, it will have a very positive impact on the future of education and the quality of teachers in our classrooms across Georgia.

Another excellent example of the work our staff is doing is the development of Guidelines for Ethical Consideration in Using AI for Educators. We are deep into this work with a wonderful advisory group of professionals, again with broad engagement from a variety of stake holders including teacher voice, principals, a superintendent, board member, CTO's from school districts and RESA's, Colleges and University representatives, DOE representatives, and public and private consultants, just to name some of the task force participants. Toward the aim of helping educators avoid ethical missteps when using AI, the representative AI Guidance Development Committee completed the Guidelines for Ethical Considerations in Using AI for Educators draft, which was distributed for review to Superintendents, HR Directors, Educator Preparation Providers, and others. After all feedback is received by May 20, 2025, the Committee will come back together to finalize the Guidance for publication and distribution with a target date of June 16, 2025. We will be developing preventive ethics training around the Guidance principles, standards, and guiding questions, and look forward to making available resources and exemplars to assist pre-service and in-service administrators, educators, and staff with the responsible use of AI. This draft will be posted for public comment in the coming weeks, and I do hope our commissioners will be able to review and offer relevant feedback. Kudos to Ms. Anne Marie Fenton (Assessment and Rules) and Mr. David Pumphrey (Ethics) for serving as project leaders. Last, but not least, I want to encourage our Commissioners to review the results of the Retired Teachers Return to Work performance audit prepared by the Department of Audits and Accounts, pursuant to Georgia House Bill 385. The Teachers Retirement System of Georgia, The Georgia Department of Education, and the Georgia Professional Standards Commission participated in the review and provided responses to the Georgia Department of Audits and Accounts. #### VI. GACE STANDARD SETTING

Anne Marie Fenton introduced Eric Steinhauer, Evaluation Systems. They shared a PowerPoint presentation on the GACE standards setting process along with recommendations for the Ethics for Teacher and Ethics for Leaders assessments.

**MOTION:** (Jimmy Atkins / Dr. Franklin Perry) To formally establish the following passing scores effective July 1, 2025, for the Ethics Assessments as follows:

- Ethics for Teachers (Test Code 351) to equal the Recommended Study Value (RSV) (23 raw score points); and
- Ethics for Leaders (Test Code 352), to equal the RSV (25 raw score points).

**<u>PSC ACTION:</u>** Approved

#### VII. <u>RULES ADOPTION</u>

Anne Marie Fenton presented the rules for adoption. There were 14 Certification and 3 Educator Preparation rules that were initiated at the March 13th Commission meeting. These rules, if adopted, will become effective July 1, 2025. No public comments were received.

**505-2-.05 PROFESSIONAL CERTIFICATE** - It is proposed that GaPSC Rule 505-2-.05 PROFESSIONAL CERTIFICATE, dated July 1, 2020, be AMENDED to include a change in testing providers resulting in new assessment titles, the addition of the new state-required literacy assessments in compliance with The Georgia Early Literacy Act (HB 538) of 2023 along with changes to both organize format and include information for clarity and consistency.

**505-2-.09 NON-RENEWABLE PROFESSIONAL CERTIFICATE -** It is proposed that GaPSC Rule 505-2-.09 NON-RENEWABLE PROFESSIONAL CERTIFICATE, dated July 1, 2020, be AMENDED to include the addition of the new state-required literacy assessments in compliance with the Georgia Early Literacy Act (HB 538) of 2023 and changes to both organize format and include information for clarity and consistency.

**505-2-.10 PERMIT -** It is proposed that GaPSC Rule 505-2-.10 PERMIT, dated April 15, 2024, be AMENDED to include a change in testing providers resulting in new assessment titles and the addition of new state-required literacy assessments in compliance with The Georgia Early Literacy Act (HB 538) of 2023, update an endorsement that may be added to a Permit, and changes to both organize format and include information for clarity and consistency.

**505-2-.21 CERTIFICATION BY INTERSTATE RECIPROCITY** - It is proposed that GaPSC Rule 505-2-.21 CERTIFICATION BY INTERSTATE RECIPROCITY, dated

July 1, 2021, be AMENDED to include the requirement of the new state-required literacy assessments in compliance with The Georgia Early Literacy Act (HB 538) of 2023 and changes to both organize format and include information for clarity and consistency.

**505-2-.22 CERTIFICATION BY STATE-APPROVED PROGRAM -** It is proposed that GaPSC Rule 505-2-.22 CERTIFICATION BY STATE-APPROVED PROGRAM, dated April 15, 2024, be REPEALED and that a new rule with the same number and title be ADOPTED to include the addition of a new state-required literacy assessments in compliance with The Georgia Early Literacy Act (HB 538) of 2023 and changes to both organize format and include information for clarity and consistency.

**505-2-.24 SPECIAL GEORGIA REQUIREMENTS -** It is proposed that GaPSC Rule 505-2-.24 SPECIAL GEORGIA REQUIREMENTS, dated April 15, 2021, be AMENDED to include a change in testing providers resulting in new assessment titles, the addition of a new state-required literacy assessments in compliance with The Georgia Early Literacy Act (HB 538) of 2023, removal of the test-in option for the fields of Middle Grades Reading 4-8 and Reading P-12 and changes to both organize format and include information for clarity and consistency.

**505-2-.26 CERTIFICATION AND LICENSURE ASSESSMENTS** - It is proposed that GaPSC Rule 505-2-.26 CERTIFICATION AND LICENSURE ASSESSMENTS, dated April 15, 2024, be to be REPEALED and that a new rule with the same number and title be ADOPTED to include a change in testing providers resulting in new assessment titles, the addition of the new state-required literacy assessments in compliance with The Georgia Early Literacy Act (HB 538) of 2023 along with changes to both organize format and include information for clarity and consistency.

**505-2-.34 ADD A FIELD -** It is proposed that GaPSC Rule 505-2-.04 ADD A FIELD dated January 1, 2020, be AMENDED to include a change in testing providers resulting in new assessment titles, the addition of the new state-required literacy assessments in compliance with The Georgia Early Literacy Act (HB 538) of 2023, removal of the test-in option for the fields of Middle Grades Reading 4-8 and Reading P-12, and changes to both organize format and include information for clarity and consistency.

**505-2-.36 RENEWAL REQUIREMENTS** - It is proposed that GaPSC Rule 505-2-.36 RENEWAL REQUIREMENTS, dated April 15, 2021, be AMENDED to include accepting continuing education courses accredited by the International Dyslexia Association (IDA), as IDA training is accepted by the Georgia Department of Education to satisfy literacy training requirements of the Georgia Early Literacy Act (HB 538) of 2023.

**505-2-.45 MONTESSORI CERTIFICATE -** It is proposed that GaPSC Rule 505-2-.45 MONTESSORI CERTIFICATE, dated July 1, 2022, be AMENDED to include a change in testing providers resulting in new assessment titles and the addition of new state-required literacy assessments in compliance with The Georgia Early Literacy Act (HB 538) of 2023 along with changes to both organize format and include information for clarity and consistency.

**505-2-.46 MILITARY SUPPORT CERTIFICATE** - It is proposed that GaPSC Rule 505-2-.46 MILITARY SUPPORT CERTIFICATE, dated April 15, 2025, be AMENDED to include a change in testing providers resulting in new assessment titles and the addition of new state-required literacy assessments in compliance with The Georgia

Early Literacy Act (HB 538) of 2023 along with changes to both organize format and include information for clarity and consistency.

**505-2-.87 HEALTHCARE SCIENCE** - It is proposed that GaPSC Rule 505-2-.87 HEALTHCARE CERTIFICATE, dated July 1, 2022, be AMENDED to include a change in testing providers resulting in new assessment titles, the addition of the new state-required literacy assessments in compliance with The Georgia Early Literacy Act (HB 538) of 2023 changes, the option for certification based on an expired healthcare license in good standing, and to both organize format and include information for clarity and consistency.

**505-2-.90 CAREER AND TECHNICAL SPECIALIZATIONS -** It is proposed that GaPSC Rule 505-2-.90 CAREER AND TECHNICAL SPECIALIZATIONS, dated July 1, 2022, be AMENDED to include a change in testing providers resulting in new assessment titles, the addition of the new state-required literacy assessments in compliance with The Georgia Early Literacy Act (HB 538) of 2023 changes, the option for certification based on an expired industry license in good standing, and to both organize format and include information for clarity and consistency.

#### **Educator Preparation**

**505-3-.01 REQUIREMENTS AND STANDARDS FOR APPROVING EDUCATOR PREPARATION PROVIDERS AND EDUCATOR PREPARATION PROGRAMS -** It is proposed that GaPSC Rule 505-3-.01 REQUIREMENTS AND STANDARDS FOR APPROVING EDUCATOR PREPARATION PROVIDERS AND EDUCATOR PREPARATION PROGRAMS dated January 1, 2025, be AMENDED to incorporate Literacy Assessment requirements and to update assessment requirements for the fields of Teacher Leadership and Educational Leadership Tier II. Additional, non-substantive changes are proposed for clarification.

**505-3-.76 ALTERNATIVE PREPARATION FOR EDUCATIONAL LEADERSHIP PROGRAM -** It is proposed that GaPSC Rule 505-3-.76 ALTERNATIVE PREPARATION FOR EDUCATIONAL LEADERSHIP PROGRAM dated June 15, 2024, be AMENDED to revise assessment requirements for Educational Leadership Tier II programs, and to clarify that a Level 5 certificate is required for admission to a Tier I program.

**505-3-.77 EDUCATIONAL LEADERSHIP PROGRAM -** It is proposed that GaPSC Rule 505-3-.77 EDUCATIONAL LEADERSHIP PROGRAM dated April 15, 2024, be AMENDED to revise assessment requirements for Educational Leadership Tier II programs, and to clarify that a Level 5 Certificate is required for admission to a Certification-only Tier I program.
