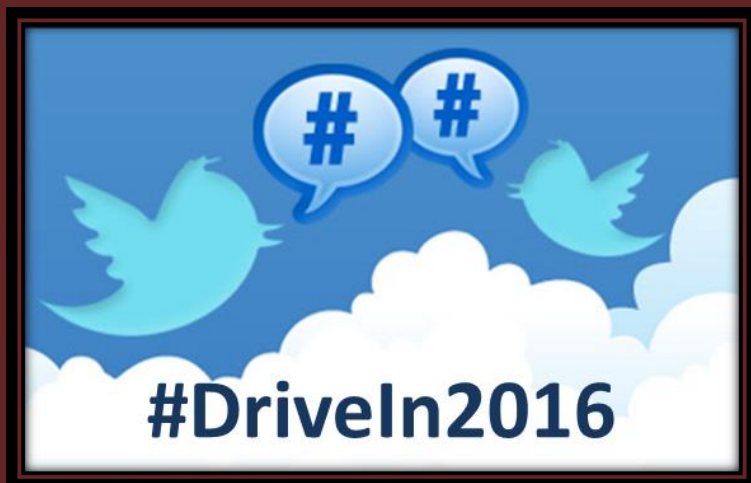

Slated for Adoption 12/8

- PPEMs and Annual Reporting –505-3-.02
- School Counseling Program – 505-3-.67
- Alternative Preparation for Educational Leadership – 505-3-.76

Recently Amended Rules

- Art Education Program – 505-3-.44
- Dance Education Program – 505-3-.45
- Drama Education Program – 505-3-.46
- Music Education Program – 505-3-.50
- GaTAPP – Rule 505-3-.05
- “Mother Rule” – Rule 505-3-.01

Rule .01 Process – Year 1

- Staff recommendations
- Task Force revisions & recommendations
- Amended Rule drafted
- EPPs surveyed (n = 84)
- Survey results informed additional revisions
- Final review by staff
- Commission consideration

Rule .01 Process – Year 2

- Public comment period resulted in reconsiderations
- The rule was pulled from adoption agenda
- Revisions were made to address concerns of EPPs
- The rule was initiated in July
- No public comments were received
- Rule adoption – September; Effective date - October

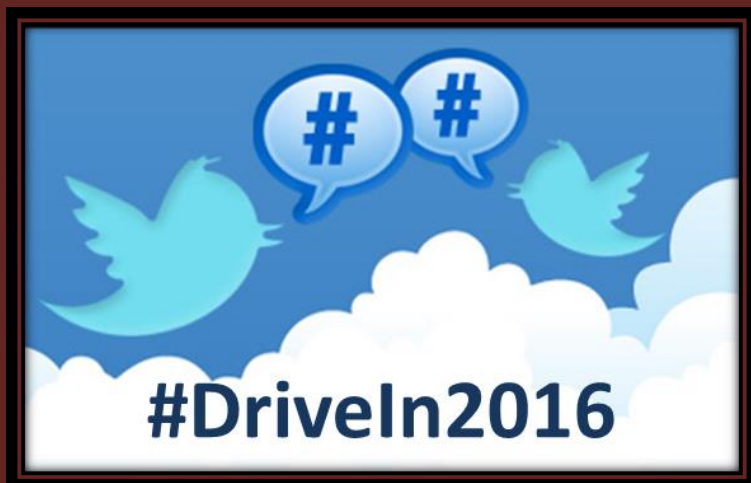
