

# The Pre-Service Certificate

# Purpose

- **Required for anyone participating in student teaching in Georgia after 07/01/2015**
- **Assures the safety of school children**
- **Standardize criminal background check process across the state for Pre-Service teachers; eliminating those not eligible/suited for profession**
- **Assist Pre-Service educators in understanding the Georgia Educator Code of Ethics as well as hold them accountable under the code**

# When is Pre-Service not needed?

- **Professionally certified teachers**
- **Permit holders**
- **If the candidate holds a current Non-Renewable Non-Professional certificate (NNT), Induction certificate, or a Waiver, the Pre -Service certificate is not required.**
- **Candidates enrolled in GaTAPP. These individuals are issued an IN4**
- **Candidates enrolled in Service or Leadership field programs**

# Exceptions

- **Candidates holding a Certificate of Eligibility will need the Pre-Service certificate, even though they may have already completed a certification program, as the COE is not a certificate**

**Example: Candidate completed a program in Special Education and has a COE for an IN1. Candidate just enrolled in a state-approved Master's degree program for Early Childhood Education.**

- **Paraprofessional certificate holders**

**The Pre-Service certificate is not a professional educator certificate. It only allows the holder to participate in supervised field experience, clinical practice, student teaching, or residency work in Georgia schools.**

**A student can be issued an IN4 or Waiver at the request of the Local Unit of Administration after Pre-Service is issued. The Pre-Service certificate will be made obsolete.**


# Validity

**Valid for 5 years**

**Invalidated upon:**

- **Program Completion**
- **Withdrawal, transfer, or removal from program. Will be invalidated after 10 days from when candidate is withdrawn.**

# Steps for Pre-Service Issuance



- **EPP admits candidate if he/she meets PAA and GPA minimum of 2.5.**
- **EPP input candidates' information in TPMS**
- **Candidate claims program in MyPSC**
- **Candidate takes Ethics Entry test if enrollment if after 7/1/14 and completes app, VLP**
- **EPP submits Pre-Service package through ExpressLane**

# HOW TO CLAIM PROGRAM?

## Program

Enrollees in traditional educator preparation programs cannot take a GACE content assessment until made eligible by their program provider. Educator preparation program providers report your enrollment, and you must claim your enrollment you were made eligible to test. Eligibility to take a GACE assessment depends on many factors which vary from provider to provider.



# GCIC Background Check

- \* Once Pre-Service documents are verified, a Georgia Crime Information Center (GCIC) criminal record check is conducted
- \* If candidate responded “No” to all Personal Affirmation questions on application and the criminal record check does not contradict those answers, the Pre-Service Certificate is issued through the candidates MyPSC account
- \* If candidates responded “Yes” to any Personal Affirmation questions, OR the answers are not consistent with the report generated by GaPSC, an ethics investigation is conducted. The Commission reviews the results and issues one of the following decisions:
  - \* Candidate is cleared and Pre-Service Certificate is issued
  - \* Candidate is given a warning and Pre-Service Certificate is issued
  - \* Candidate is given a reprimand and the Pre-Service Certificate is issued
  - \* Candidate is denied the Pre-Service Certificate

If a Pre-Service Certificate holder violates the Code of Ethics, must the violation be reported to GaPSC?



**YES. Pre-Service Certificate holders are certified individuals, and they are expected to uphold the Code of Ethics. Both program providers and school districts are equally responsible for reporting suspected violations of the Code of Ethics to GaPSC. All educators are mandated reporters and are required to report alleged misconduct. For the educator, failure to report could result in a sanction of the educator's certificate.**







- **Passing score on edTPA, the GaPSC-approved content pedagogy assessment**
- **Completion of a course in identifying and educating exceptional children**





- **Completion of a course in identifying and educating exceptional children is not required for initial issuance of an Induction Pathway 3 certificate, but it is required for conversion to a Professional certificate or reissuance of the Induction certificate**
- **A passing score on the Georgia Educator Ethics Assessment - Program Exit (Test Code 360) will be required for conversion to a Professional certificate or reissuance of the Induction certificate**



- **A bachelor's degree or higher. If highest degree is a bachelor's degree and it was earned less than 10 years prior to the date of application, must have a minimum overall GPA of 2.5. If not, may still qualify by submitting proof of acceptance into a GaPSC-accepted educator preparation program**
- **Passing score on the GACE Program Admission Assessment, or exemption**
- **Induction level or higher passing score on the appropriate GACE content assessment**
- **Complete Georgia Educator Ethics Assessment - Program Entry (Test Code 350)**

# Program Admission Testing Requirement

## **Required**

Graduates of Georgia Teacher Preparation- Program Admission testing (or exemption) is required as a part of Georgia-approved preparation program entrance requirements.

For Some Non-Renewable Certificate Holders-In order to receive an Induction-Pathway 4 certificate you must pass (or exempt) the GACE Program Admission Assessment, as well as satisfy all other eligibility requirements for this certificate type.

## **Not Required**

For Prior Certificate Holders- If you hold a current or expired Georgia Clear Renewable (professional) certification, you are not required to take a Program Admission assessment in Georgia.

For Holders of Certificates from Other States- If you hold a current or expired professional certificate from another state or are being recommended for certification from a preparation program approved in another state, you are not required to take a Program Admission assessment in Georgia.


