

Summary of Proposed Changes to GaPSC Educator Preparation Rules

March 14, 2019 Initiation

505-3111	P-5 Agriculture Education Endorsement	This new rule establishes standards and expectations for endorsement programs that prepare individuals certified in Agriculture Education (6-12) to teach agriculture education content to children in grades P-5.
505-301	Requirements and Standards for Approving Educator Preparation Providers and Educator Preparation Programs	Changing all instances of Early Childhood Education or ECE to Elementary Education. Additionally, outdated language regarding the moratorium for review/approval of out-of-state educational leadership preparation programs is being removed. The moratorium ended October 2018.
505-305	Georgia Teacher Academy for Preparation and Pedagogy Program (GaTAPP)	Changing all instances of Early Childhood Education or ECE to Elementary Education.
505-314	Early Childhood Education	Changing all instances of Early Childhood Education or ECE to Elementary Education.
