

Summary of Proposed Changes to GaPSC Certification Rules

October 10, 2019 Initiation Public Comment Period: November 1, 2019 – November 30, 2019

At its October 10, 2019, meeting, the Georgia Professional Standards Commission (GaPSC) initiated the rulemaking process for the Certification rules listed below. Certification Rule Changes		
Rule #	Rule Name	Summary of Rules Action
505-201	Georgia Educator Certification	This rule is being amended to include the Provisional Rule, educator responsibility when rules change, and update website information.
505-202	Classification	This rule is being amended to add the Provisional title. In addition, the Military Support and Montessori types established in previously adopted rules will be added during this rule revision.
505-204	Induction Certificate	This rule is being rescinded and a new rule with the same number and title will be initiated to reorganize and clarify requirements to qualify for an Induction certificate. There will no longer be different Induction Pathways (Pathway 1, 2, 3) or Supplemental Induction fields, and GA program completer's may now qualify for a 1 year Induction certificate at the request of a GA LUA if they have met all program requirements except for passing the edTPA/GACE content assessment.

Rule #	Rule Name	Summary of Rules Action
505-205	Professional Certificate	This rule is being rescinded and a new rule with the same number and title will be initiated to reorganize and clarify requirements to qualify for a Professional certificate. Educators applying via reciprocity may now qualify for a 1 year Non-Renewable certificate at the request of a GA LUA if they have not met the content testing requirement.
505-208	Provisional Certificate	This rule is being initiated to re-establish the Provisional certificate for individuals transitioning into a career in education. The Provisional certificate will take the place of the previously issued Induction Pathway 4 certificate.
505-209	Non-Renewable Professional Certificate	This rule is being rescinded and a new rule with the same number and title will be initiated to outline the requirements to qualify for the Non-Renewable Professional certificate.
505-213	Waiver Certificate	This rule is being rescinded and a new rule with the same number and title will be initiated to clarify requirements to qualify for a Waiver certificate.
505-214	Endorsements	This rule is being rescinded and a new rule with the same number and title will be initiated to remove references to the different Induction pathways and update the validity of the Non-Renewable endorsement certificate from 2 to 3 years.
505-220	Substitute Teaching	This rule is being amended to remove references to the Certificate of Eligibility.
505-221	Certification by Interstate Reciprocity	This rule is being rescinded and a new rule with the same number and title will be initiated to reorganize and clarify requirements to qualify for certification by interstate reciprocity. Out of state educators with less than 3 years of acceptable experience will now need to pass the Ethics Exit assessment prior to obtaining their Georgia certification.
505-222	Certification by State- Approved Program	This rule is being rescinded and a new rule with the same number and title will be initiated to update the requirements for individuals completing out-of-state programs with clinical practice completed in a Georgia school, out-of-country program completers, and to replace references to No Child Left Behind

		with ESSA verbiage. As of 7/1/20 individuals completing their student teaching in Georgia must be placed for a minimum of one full semester.
505-223	Requirements Letter	GaPSC rule 505-223 Certificate of Eligibility is being rescinded and a new rule with the same number and titled Requirements Letter will be initiated to outline the scenarios in which the GaPSC will outline outstanding requirements.
505-224	Special Georgia Requirements	This rule is being rescinded and a new rule with the same number will be initiated to update the experience requirements for out-of-state educators and revise the content knowledge assessment requirement section. These changes will allow issuance of a one-year Induction certificate to Georgia program completers who have not passed the content exam or edTPA, and issuance of a one-year Induction or Nonrenewable certificate to out-of-state program completers who lack the required certification assessments.
505-225	Experience Requirements	This rule is being rescinded and a new rule with the same number and title will be initiated to simplify language, provide greater clarity, and to coincide with revisions in connected certification rules. A Out of state experience no longer needs to be within the past 5 years to be acceptable to exempt a special Georgia requirements.
505-226	Certification and Licensure Assessments	This rule is being rescinded and a new rule with the same number and title will be initiated to a update the Georgia Educator Ethics – Program Exit Assessment requirements and replace a Induction Pathway language with Provisional. The Program Exit assessment will now be required in order to qualify for Induction certification.
505-227	Certification Application Procedures	This rule is being amended to remove Supplemental Induction language and allow individuals to independently apply for Induction certification.
505-228	Certification Fees	This rule is being amended to remove references to the Certificate of Eligibility.

505-232	Validity Periods and Dating of Certificates	This rule is being amended to simplify language, provide greater clarity, and to coincide with revisions in connected certification rules.
505-233	Certificate Upgrade	This rule is being amended to remove references to the different Induction pathways.
505-234	Add a Field	This rule is being rescinded and a new rule with the same number and title will be initiated to reorganize and clarify requirements to add a field to a Georgia certificate.
505-236	Renewal Requirements	This rule is being rescinded and a new rule with the same number and title will be initiated to simplify language, provide greater clarity, and to coincide with revisions in connected certification rules. A separate guidance document will be created to advise on the local administration of PLPs and PLGs.
505-245	Montessori Certificate	This rule is being rescinded and a new rule with the same number and title will be initiated to reorganize and clarify requirements to qualify for the Montessori certificate.
505-246	Military Support Certificate	This rule is being rescinded and a new rule with the same number will be initiated to reorganize and clarify requirements to qualify for the Military Support Certificate and to include the process for military members called to active duty during their certificate validity.
505-287	Healthcare Science	Thi s rule is being rescinded and a new rule with the same number and title will be initiated to reorganize and clarify requirements to qualify for certification in Healthcare Science.
505-290	Career and Technical Specializations	This rule is being rescinded and a new rule with the same number and title will be initiated to reorganize and clarify requirements to qualify for certification in Career and Technical Specializations.
505-2140	Audiology	This rule is being rescinded and a new rule with the same number and title will be initiated to reorganize and clarify requirements to qualify for certification in Audiology.

505-2141	Curriculum and Instruction	This rule is being rescinded and a new rule with the same number and title will be initiated to reorganize and clarify requirements to qualify for certification in Curriculum and Instruction. The field of Curriculum and Instruction can now be added to Induction certificates as an Induction field.
505-2142	Instructional Technology	This rule is being rescinded and a new rule with the same number and title will be initiated to reorganize and clarify requirements to qualify for certification in Instructional Technology. The field of Instructional Technology can now be added to Induction certificates as an Induction field.
505-2143	Media Specialist	This rule is being rescinded and a new rule with the same number and title will be initiated to reorganize and clarify requirements to qualify for certification in Media Specialist.
505-2144	School Counseling	This rule is being rescinded and a new rule with the same number and title will be initiated to simplify language, provide greater clarity, and to coincide with revisions in connected certification rules. If someone already holds a Georgia certificate, in order to add the field of School Counseling they must complete a GaPSC or CaCREP approved program in addition to meeting all special Georgia requirements for the field.
505-2145	School Nutrition Director	This rule is being amended to remove the option to qualify for this field based on completion of a GaPSC-prescribed program.
505-2146	School Psychology	This rule is being rescinded and a new rule with the same number and title will be initiated to reorganized and clarify requirements to qualify for certification in School Psychology.
505-2147	School Social Work	This rule is being rescinded and a new rule with the same number and title will be initiated to reorganized and clarify requirements to qualify for certification in School Social Work.
505-2148	Speech and Language Pathology	This rule is being rescinded and a new rule with the same number and title will be initiated to update the certificate types not issued in this field and update renewal requirements.
505-2149	Teacher Leadership	This rule is being rescinded and a new rule with the same number and title will be initiated to reorganize and clarify requirements to qualify for certification in Teacher Leadership. The field of Teacher Leadership can now be added to Induction certificates as an Induction field.

Rule #	Rule Name	Summary of Rules Action
505-2161	Career Technical Instruction (CTI) Endorsement	This rule is being amended to update the in-field statement and language for consistency.
505-2181	Teacher Leader Endorsement	This rule is being amended to remove references to the Supplemental Induction field and add that the Teacher Leader endorsement may now be added to an Induction certificate as an Induction field.
