SUBJECT: Notice of Proposed Rulemaking

Notice is hereby given that, pursuant to the authority contained in Official Code of Georgia Title 20, it is proposed that the Professional Standards Commission initiate rulemaking procedures in accordance with Georgia Administrative Procedures Act so as to provide for (1) **amending** the current rule in Chapter 505-2- Certification, effective April 15, 2023, as follows: 505-2-.39; (2) **repealing** the current rule in Chapter 505-3- Educator Preparation Rules, effective April 15, 2023, as follows: 505-3-.24, 505-3-.54, 505-3-.55, 505-3-.56, 505-3-.57, 505-3-.58, 505-3-.60, 505-3-.83, 505-3-.91, 505-3-.98, 505-3-.99, 505-3-.54, 505-3-.55, 505-3-.56, 505-3-.57, 505-3-.58, 505-3-.60, 505-3-.58, 505-3-.59, 505-3-.59, 505-3-.59, 505-3-.59, 505-3-.59, 505-3-.59, 505-3-.99, 505-3-.99, 505-3-.99, 505-3-.101, 505-3-.102, and 505-3-.113.

All interested persons shall be afforded reasonable opportunity to submit data, views, or arguments orally or in writing. Opportunity for oral hearing shall be granted if requested by 25 persons who will be directly affected by the proposed rule, by a governmental subdivision, or by an association having not less than 25 members.

505-3-98 SPECIAL EDUCATION DEAF EDUCATION ENDORSEMENT

505-3-.113 FINANCIAL LITERACY ENDORSEMENT

It is proposed that a new rule with a new name be INITIATED titled, FINANCIAL LITERACY ENDORSEMENT, to provide standards and requirements for endorsement programs that will prepare secondary teachers (6-12) to teach financial literacy to students in eleventh (11th) and twelfth (12th) grades, per the requirements set forth in Senate Bill 220, passed in the 2022 legislative session.
