**SUBJECT:** Notice of Proposed Rulemaking

Notice is hereby given that, pursuant to the authority contained in Official Code of Georgia Title 20, it is proposed that the Professional Standards Commission initiate rulemaking procedures in accordance with Georgia Administrative Procedures Act so as to provide for (1) **amending** the current rules in Chapter 505-2- Certification, effective July 1, 2021, as follows: 505-2-.21, 505-2-.142, 505-2-.163, 505-2-.164, and 505-2-.180; (2) **repealing** the current rule in Chapter 505-2- Certification, effective July 1, 2021, as follows: 505-2-.27; (3) **initiating** the current rule in Chapter 505-2- Certification, effective July 1, 2021, as follows: 505-2-.27; (4) **amending** current rules in Chapter 505-3- Educator Preparation Rules, effective July 1, 2021, as follows: 505-3-.82, 505-3-.83, 505-3-.84, 505-3-.85, 505-3-.86, 505-3-.87, 505-3-.88, 505-3-.89, 505-3-.90, 505-3-.91, 505-3-.92, 505-3-.93, 505-3-.94, 505-3-.95, 505-3-.96, 505-3-.98, 505-3-.99, 505-3-.100, 505-3-.101, 505-3-.102, 505-3-.103, 505-3-.104, 505-3-.105, 505-3-.106, 505-3-.107, 505-3-.108, 505-3-.109, 505-3-.111, and 505-3-.112; and (5) **repealing** the current rules in Chapter 505-3- Educator Preparation Rules, effective July 1, 2021, as follows: 505-3-.09, and 505-3-.97.

All interested persons shall be afforded reasonable opportunity to submit data, views, or arguments orally or in writing. Anyone interested in making a written statement may do so by submitting it to RulesComments@GaPSC.com or mail to Rules Comments, Georgia Professional Standards Commission, 200 Piedmont Avenue, SE, Suite 1712, West Tower, Atlanta, Georgia 30334-9032. It is requested that such a statement be delivered on or before April 28, 2021. Opportunity for oral hearing shall be granted if requested by 25 persons who will be directly affected by the proposed rule, by a governmental subdivision, or by an association having not less than 25 members.

The Professional Standards Commission will consider the proposed rules during its regular meeting on May 13, 2021, currently scheduled to be held virtually and begin at approximately 4:00 p.m.

#### 505-2-.21 CERTIFICATION BY INTERSTATE RECIPROCITY

It is proposed that GaPSC Rule 505-2-.21 CERTIFICATION BY INTERSTATE RECIPROCITY, dated January 1, 2020, be AMENDED to clarify requirements for Georgia certification issued based on reciprocity.

#### 505-2-.27 CERTIFICATION APPLICATION, MyPSC AND TEST ELIGIBILITY

It is proposed that GaPSC Rule 505-2-.27 CERTIFICATION APPLICATION PROCEDURES, dated January 1, 2020, be REPEALED and a new rule with a new name of CERTIFICATION APPLICATION, MyPSC AND TEST ELIGIBILITY PROCEDURES be INITIATED to require submission of the online application and supporting documentation through MyPSC when applying for certification; to submit official transcripts electronically from an institution or by parchment service; and to organize format for clarity.
